

## Provisional List of the Candidates Selected & Waitlisted for the post of Assistant Engineer (Civil) Advertised vide Advertisement No. 02/2016

Vide notification dated 02.09.2016, 17.11.2016 and 16.12.2016, the Company had notified that the on-line tests conducted on 01.06.2016 to 03.06.2016 for the various posts advertised vide Advertisements No. 01/2016, 02/2016 & 03/2016 has been cancelled and decided to conduct re-examination in phase manner of the candidates who had appeared for the aforesaid on-line tests. Accordingly, in the 2<sup>nd</sup> Phase the re-examination (On-line Test) for the post of **Assistant Engineer (Civil) & Assistant Engineer (Telecom)** has been conducted on **30.12.2016**.

- 2. Taking into consideration the performance reflected in the re-examination (On-line Test), number of post advertised, horizontal and social reservation etc., the provisional select and wait list of candidates for the post of **Assistant Engineer (Civil) is prepared.**
- 3. The candidates have been provisionally selected / waitlisted on the basis of performance reflected in the on-line written test held on 30.12.2016, which is subject to verification of documents /certificates. If candidate fails to submit all the required documents /certificates at the time of their document verification he / she will be disqualified from selection process.
- 4. The select listed canidates will be called personally for verification of their documents at the Corporate Office, Mumbai for which separate notification shall be given in our website and will also intimated through e-mail on their e-mail address given in their application form.
- 5. Before coming for document verification, the candidates should ensure that they fulfill all eligibility criteria as mentioned in the advertisement. The selection of the candidate is purely on provisional basis subject to conforming the pre-requisites and other conditions notified in the advertisement. If it is found that any candidate is not meeting the requirement of pre-requisites or not fulfilling any of the conditions, or he / she has knowingly or willfully furnished incorrect or false particulars / fake certificates or suppressed material information, his / her selection shall be liable for cancellation without any notice or assigning any reasons whatsoever.
- 6. The qualification acquired by the candidate and other required documents submitted by the candidate must be valid on the cutoff date / last date of application as mentioned in the advertisement. If it is found that candidate has not acquired qualification before cutoff date / last date of application or the documents submitted by the candidate are not valid on the cutoff date / last date of application, it shall be treated as disqualified and his / her selection will be cancelled.

At the time of document verification if it is found that the provisionally selected candidate is not eligible for further selection process, then wait listed candidate will be called for document verification. Further, if waitlisted candidate is also found not eligible then company reserves the right to publish new provisional select / wait list of further merit-listed candidates.
- 8. The provisional select / wait list will be valid for the periods of 1 year from date of publish.
- 9. The provisional select / wait list does not confer any automatic right of possible employment with the Company.
