Staff Selection Commission conducted OMR based examination for 200 marks on 23.07.2016 for recruitment of Data Entry Operator Gr. B in Labour Bureau, Chandigarh as per details given below :

Marks scored by the candidates have been uploaded on website www.sscnwr.org.

2. Earlier 12 candidates for the post of Data Entry Operator Gr. B were called for Document Verification in SSC(NWR), Chandigarh on 15.09.2016 as per the ratio/minimum qualifying criteria decided by the Commission. But, considering the vacancy position, availability of the candidates etc the Commission has fixed the following minimum qualifying marks in the written examination for appearing in Document Verification under different categories as under:-


3. Accordingly, 06 additional candidates of Data Entry Operator Gr. B have been shortlisted for Document Verification in accordance with the ratio of 1:3 for each vacancy in each category subject to the minimum qualifying marks. The cut off marks for different categories of candidates called for Document Verification are as under :

4. The Commission has decided to hold Document Verification for these additional candidates on 06.10.2016. The Essential Qualification for the post of Data Entry Operator Gr.B is on or before 27.12.2013 as per closing date of the advertisement. The candidates who would be found eligible would be selected as per the merit of written examination subject to verification of educational certificates, other certificates and production of valid OBC certificate (wherever applicable) in Central Government format with certificate on Creamy Layer status obtained within three years before the closing date. However the Commission has decided to accept OBC certificate in the prescribed format, issued after the closing date but before the last tier of the examination as the case may be, as a valid proof of belonging to OBC category.

5. The results of written exam for document verification are provisional and subject to the recommended candidates fulfilling all the eligibility conditions prescribed for the respective posts in the Notice of Examination and also subject to thorough verification of their identity with reference to their photograph, signature, handwriting etc. on the application form, admission certificate etc. The candidatures of the candidate are liable to be cancelled by Deputy Regional Director in case candidates found not fulfilling the eligibility conditions or any other genuine reasons.
6. For candidates belonging to reserved categories for whom certain percentage of vacancies are reserved as per Government Policy, the category status is indicated against their Roll Numbers. It is important to note that some of these candidates have been declared qualified only for the category mentioned against their Roll Numbers. If any candidate does not actually belong to the category mentioned against his/her name, he/she may not be eligible to be included in the list. It is, therefore, in the interest of the candidates concerned to immediately contact the Regional Office of the Commission in all such cases where they do not belong to the category shown against their Roll Number.
7. Candidates may note that as per Notice(s) of the Examinations and instructions given in the answer sheets, they were required to code/write their particulars correctly and append their signature/Left Thumb Impression (LTI) on the answer sheets. Such answer sheets which are without signature/LTI and where particulars such as name, Roll number, Ticket Number and Language have been coded incorrectly, have been rejected/awarded ZERO marks.
8. The schedule of Document Verification is available on the website of the Commission www.sscnwr.org. Admit Cards for additional candidates being called for Document Verification are also available on website and may be downloaded for appearing for document verification on scheduled date and time.
9. Marks of candidates are available on the Commission's regional office website www.sscnwr.org. The final result will be declared on the basis of merit-cum- document verification and subject to the vacancies.
