2. Keeping in view the vacancy position, details of provisionally qualified candidates for appearing document verification has been uploaded on website, subject to their fulfilling all eligibility conditions. The Commission has fixed the following cut-off marks in the written examination for appearing in document verification under different categories is as under:-

3. On the basis of the above cut-off, the Selection posts at S.No.7,8,9,11 &12 will remain unfilled as no candidate scored cut off level marks in these selection category post. The Commission has decided to hold Document Verification for provisionally eligible candidates on **05.10.2016** for the Sl.No.1 to 6 & 10 Selection category post. The Essential Qualification for all the respective posts is on or before 01.06.2015 i.e. closing date of the advertisement. The candidates will be selected among provisionally qualified candidates according to the merit subject to verification of educational certificates other certificates and production of valid OBC certificate (wherever applicable) in Central Government format with certificate on Creamy Layer status should have been obtained within three years before the closing date. However the Commission has decided to accept OBC certificate in the prescribed format, issued after the closing date but before the OMR examination i.e. 23.07.2016 as the case may be, as valid proof of belonging to OBC category. It is compulsory to submit/verify these educational and other certificates on 05.10.2016 for verification.

4. The results of written exam for document verification are **provisional** and subject to the recommended candidates fulfilling all the eligibility conditions prescribed for the respective posts in the Notice of Examination and also subject to thorough verification of their identity with reference to their photograph, signature, handwriting etc on the application form, admission certificate etc. The candidatures of the candidate are liable to be cancelled by Regional Director in case candidates found **not** fulfilling the eligibility conditions or any other genuine reasons.

5. For candidates belonging to reserved categories for whom certain percentage of vacancies are reserved as per Government Policy, the category status is indicated against their Roll Numbers. It is important to note that some of these candidates have been declared qualified only for the category mentioned against their Roll Numbers. If any candidate does not actually belong to the category mentioned against his/her name, he/she may not be eligible to be included in the list. It is, therefore, in the interest of the candidates concerned to immediately contact the Regional Office of the Commission in all such cases where they do not belong to the category shown against their Roll Number.

6. Candidates may note that as per Notice of the Examinations and instructions given in the answer sheets, they were required to code/write their particulars correctly and append their signature/Left Thumb Impression (LTI) on the answer sheets. Such answer sheets which are without signature/LTI and where particulars such as name, Roll number, Ticket Number and Language have been coded incorrectly, have been rejected/awarded ZERO marks.
