1. The Staff Selection Commission conducted Computer Based Written Examination for 10th Level and 12th Level for 200 marks on 26.03.2017 for recruitment of following Selection Posts, the details are as under:

Keeping in view the vacancy position & cut-off mark scored by the candidates in Computer Based Examination, the provisionally eligible candidates list for Document Verification has been uploaded on website. 3. The Commission has decided to hold Document Verification for provisionally eligible candidates on **01.06.2017** for the above mentioned posts. The Essential Qualification for all the respective posts is **on or before 02.10.2016** i.e. closing date of the advertisement. Candidates shortlisted, must bring all necessary document (in original) mentioned in call letter for Document Verification. The production of valid OBC certificate (wherever applicable) in Central Government format with certificate on Creamy Layer status should have been obtained within three years before the closing date.

4. The candidates whose Roll Nos. Figure in the list for Document Verification are subject to their fulfilling all the eligibility criteria/requirements as prescribed for the post in the Notice and also subject to through verification of their identity with reference to their photograph, signature, handwriting etc on the application form, admission certificate etc. It is found that any candidate does not fulfil any of the eligibility conditions, he/she will not be eligible for consideration of above post.
