

STAFF SELECTION COMMISSION

Constable (GD) Exam, 2011 - Revision of Result of candidates.

Recruitment of Constable (GD) in BSF, CISF, CRPF and SSB was held on 05.06.2011 at various centres across the country. The final result of the above examination was declared on 18.11.2011.

2. Several references were received from all Regional Offices for revised result of candidates on account of change in Category, State Code, Border/Naxal states, Options, medical result etc. As decided by Commission, revised result of such 1881 candidate has been processed as per the following details:

- (a) 492 male candidates belonging to NWR whose medical result has been revised from Unfit/Absent/Rejected to FIT, (Hissar Medical Board)
- (b) 1364 male and 25 female candidates whose results are to be revised due to various other reasons as indicated above.

4. Following number of male candidates have qualified for Select List / Reserve List in the Revised Result (A: BSF, B: CISF, C: CRPF, D: SSB) :-

6. Rank numbers have been allotted in order of merit based on total marks obtained by the candidates in the written examination. Tie cases have been resolved by :-

- (a) Referring to the marks in Part-A of the written paper i.e. a candidate having more marks in Part-A is given preference.
- (b) If the tie still persists, the candidate older in age is given preference.
- (c) If the tie still persists, it is finally resolved by referring to the alphabetical order of names i.e. a candidate whose name begins with the alphabet which comes first in the alphabetical order is given preference.

7. Candidates in reserve list will be en-bloc junior to candidate in Select List.

8. The lists are provisional subject to verification of their eligibility and verification of State of Domicile.
