

STAFF SLELECTION COMMISSION

Junior Engineers (Civil, Mechanical, Electrical, Quantity Surveying and Contract) Exam.,2012- declaration of result of candidates qualified for evaluation of Paper-II.

Staff Selection Commission conducted an open competitive examination for recruitment to the post of Jr. Engineers (Civil, Mechanical, Electrical, Quantity Surveying and Contract) Exam. 2012 on **8.4.2012** on all India basis. Against **186938** registered candidates, **102145** candidates actually appeared in the said examination.

2. Answer keys of question papers of Paper-I were uploaded on the Commission's website on **13.4.2012** for information of the candidates stipulating that discrepancies, if any, in the keys may be brought to the notice of the Commission at the earliest and latest by **23.4.2012**. In response to that 26 representations were received by the Commission. Representations received from the candidates about incorrect questions and their answers in the question papers used by the Commission in this examination **have been carefully examined and answer taken into account before evolution of P-I.**

3. In all **1,02,145** candidates appeared in Paper-I and out of whom **8993** candidates were awarded zero marks due to wrong coding/without signature/without LTI as per instructions given on the front page of OMR answer sheets and in the Notice of the examination, and those awarded zero marks found in possession of mobile phones, calculators and using unfair means in the Examination Hall.

4. Based on the cut-off fixed by the Commission, following is the category wise details of **5025 candidates** qualified for evaluation of Paper-II of **Civil Engineering** and **1986 candidates** qualified for evaluation of P-II of Electrical/Mechanical Engineering.

5. List of additional candidates qualifying in Paper-I for post in Central Water Commission, if any will be placed on the website in due course.

6. The list of candidates declared qualified for evaluation of Paper-II is **purely provisional** and subject to candidates' fulfilling all the eligibility conditions. Name, roll number, ticket number and other details furnished in the mark lists are as provided and/or marked by the candidates in their OMR answer sheets. In case of mismatch of any of details, the candidate may not qualify in Paper-I. Therefore, such candidates should contact the respective regional offices of the Commission immediately.

7. Result of Paper – I has been processed on the basis of data from OMR answer sheets and regional offices. Candidates belonging to reserve category for whom certain percentage of vacancies are reserved as per policy of Government, the category status is indicated against their roll number as written and coded by them in their OMR answer sheet. It is important to note that some of these candidates have been declared qualified only in the category mentioned against their roll number. If any candidate actually does not belong to the category mentioned against his/her name, or there is any discrepancy between name and roll no. which one reproduced as in OMR answer sheets, he/she may not be eligible to be included in the list. It is, therefore, in the interest of candidates concerned to contact immediately the respective regional offices of the Commission in all such cases where they do not belong to the category against their roll number.
