

## HIGH COURT OF ANDHRA PRADESH :: HYDERABAD

### PARTICULARS OF THE CUT OFF MARKS AS FIXED BY THE HON'BLE HIGH COURT IN RESPECT OF THE CANDIDATES BELONGING TO ALL CATEGORIES:

#### I. DIRECT RECRUITMENT

In respect of candidates belonging to all the Categories who have applied under Direct Recruitment the cut off mark is: --- **61**

However, as there is short fall of some candidates in respect of the categories detailed below, some more candidates who have secured less than 61 marks are included in the qualified list:

#### **(A) OC (Women) (PH)**

(Since only two candidates have secured the cut off mark of 61 and in view of short fall of 8 candidates, another 8 candidates are included as qualified candidates. The candidate at Sl.No.10 of this category secured 31 marks)

#### **(B) BC-E (Women) Category**

(Since 9 candidates have secured the cut off mark of 61 and in view of short fall of 1 candidate, the candidate at Sl.No.10 is included as a qualified candidate. The candidate at Sl.No.10 of this category secured 58 marks)

#### **(C) SC (Women) Category**

(Since 21 candidates have secured the cut off mark of 61 and in view of short fall of 9 candidates, another 9 candidates are included in the list as qualified candidates. The candidate at Sl.No.30 secured 58 marks. Similarly, the candidates at Sl.Nos.31 and 32 also secured same marks and as such, they are also included in the list as qualified candidates.)

#### **(D) ST Category**

(Since 10 candidates have secured the cut off mark of 61 and in view of short fall of 60 candidates, another 60 candidates are included in the list as qualified candidates. The candidate at Sl.No.66 got 41 marks. Similarly the candidates at Sl.Nos.67 to 71 also secured 41 marks and as such they are also included in the list as qualified candidates.)

#### **(E) ST (Women)**

(Since none of the candidates who appeared for the Screening Test under this category, secured the cut off mark of 61, the candidates at Sl.Nos.1 to 30 of this category are included in the list as qualified candidates. The candidate at Sl.No. 30 in this category has secured 26 marks.)

#### II. RECRUITMENT BY TRANSFER

In respect of the candidates who have applied under Recruitment by Transfer, since 13 vacancies are earmarked for recruitment by transfer, 130 candidates are to be called for written/final examination. The candidate at Sl.No.130 secured 62 marks and so also Sl.No.131 and 132 secured 62 marks and hence Sl.Nos. 1 to 132 of the Merit List of the candidates who appeared for the Screening Test under Recruitment by Transfer are to be called for the Written/Final examination.
