Combined Graduate Level Examination, 2011-Declaration of result of first module of CPT (DEST) for calling candidates for Module -II & Module-III

The Staff Selection Commission conducted Skill Test(DEST/Word Processing) of the candidates declared qualified for Interview for posts and had opted for the post of CSS/Asstt. in Combined Graduate Level Exam.,2011.

2. Following is the list of **1619 candidates provisionally** qualified for Module-II & Module-III of Computer Proficiency Test on the basis of result of Module-I – DEST/Word Processing. Taking into account the tentative vacancies, the Commission has fixed cut-off of 5% in mistakes for UR and relaxed standards for other categories.

Note: 279-SC,34-ST,519-OBC are provisionally qualifying at UR standard in Module-I of CPT apart from UR figure shown above.

3. The above results are based on data sent by Regional Offices of the Commission so far and are subject to verification of their options furnished in the Application Form. Inclusion of any candidates in list of the post for which he/she has not opted will not confer any right on his/her consideration for any post for which he/she had not exercised option.

4. The list herein **is provisional**. The candidates whose Roll numbers figure in the lists would be called for **CPT(Module-II & III)** subject to their fulfilling all the eligibility conditions/requirements as prescribed for the respective posts in the 'Notice' of Examination and also subject to thorough verification of their identity with reference to their photographs, signatures, handwritings, preference, etc., on the application forms, admission certificates, etc. If on verification from the application form, it is found that any candidate does not fulfill any of the eligibility conditions, he/she will not be called for **CPT(Module-II & III)**. **Despite qualifying at UR standards in Module-I of CPT, candidates belonging to reserved categories and who had availed any relaxation at any stage of the examination, will be considered only against vacancies reserved for respective categories.**

5. The category status in respect of candidates belonging to reserved categories has been indicated along with their roll numbers. It is important for the candidates belong to the reserved category for whom certain percentage of vacancies are reserved as per

Government policy, to note that if any of them does not actually belong to the category shown against his/her roll number, he/she may not be eligible for appearing in the **CPT(Module-II & III)**. It is, therefore, in the interest of the candidates concerned to contact immediately the respective Regional Offices of the Commission if they do not belong to the category shown against their roll numbers. Similarly, in case of any discrepancy in Roll Number & Name, such discrepancy must be brought to the notice of Regional Office for examination expeditiously.

6. Tentatively, the **CPT(Module-II & III)** is expected to commence w.e.f. **13.2.2012**. The actual programme of CPT(Module-II & III) region-wise will be available on the Regional websites in due course. Detailed programmes of **CPT(Module-II & III)** will be placed on the website of the respective Regional Offices by **31.1.2012**. Qualified eligible candidates are advised to get in touch with the concerned Regional Office, if they do not get the call letters by **6.2.2012**.
