2. Compensation and other benefits

In addition to Basic Pay the Executives are eligible for Industrial DA as applicable, HRA @ of 20% of Basic pay, Perks upto 49 % of Basic Pay, Contributory Provident Fund, Accident Insurance coverage, Reimbursement of Medical expenses under the Contributory Medial Insurance policy, Leave encashment, Performance Payment etc as admissible. 3. **Age**

The upper age limit prescribed for all posts shall be as on 31 July 2012. The upper age limit is relaxable by 3 years for OBC (Non Creamy Layer) candidates, 5 years for SC/ST candidates and 10 years for Persons with Disabilities. Age relaxation of five years applicable for candidates who have been domicile of J&K during the period 01.01.1980 to 31.12.1989 as per Government of India guidelines.

4. **Method of Selection**

For all the posts, selection process will be held at Kochi. For posts at Sl No. (i) to (v) the method of selection will include a Group discussion /Personal Interview. For posts at Sl No. (vi) to (viii) the selection process will include a Written test/Group discussion and followed by a Personal Interview.

5. **Application Fee**

Application fee of Rs. 300/-(Non refundable) for all posts. Fee remitted in the form of a crossed DD drawn in favor of COCHIN SHIPYARD LIMITED on any Nationalised bank payable at Kochi should be sent along with the application form. SC/ST/PWD (Minimum 40% of disability) of candidates are exempted from payment of application fee.

6. **General Conditions/ Information**

- (i) Only Indian nationals are eligible to apply.
- (ii) Government of India Directives on reservation for SC/ST/OBC/PWD candidates will apply and be strictly followed.
- (iii) In the case of Persons With Disabilities the degree of disability should be between 40% and 50%. The candidate should possess latest Certificate to this effect issued by an authorised Medical Board constituted by the Government of India / State Government.
- (iv) Post qualification experience only will be considered. Period of experience will be reckoned as on 31 July 2012. Applicants meeting requirement and short-listed will be required to appear for the Test / Group Discussion / Personal Interview at Kochi. Candidates are advised to make sure that they are meeting the eligibility requirements for the post before applying.
- (v) The minimum qualification stipulated for all the posts must be from an Indian University/Institute recognized by AICTE/recognized by the appropriate statutory authority in India and should be of regular/full time courses.
- (vi) Where percentage of mark is not awarded by the University and only grades like GPA,CGPA are awarded, the same should be converted to the equivalent percentage of marks as per the following formula. On a 10 point scale CGPA/GPA of 6.0 will be considered as 60%.
- (vii) For reserved posts SC/ST candidates who have secured 55% marks and above in the qualifying examination will also be considered, provided they satisfy all other requirements.
- (viii) Depending upon number of applications received for all the posts, Shipyard reserves the right to relax age and experience requirements for those who have experience of working in a Shipyard.

- (ix) Candidates appearing for interview shall be reimbursed single to & fro 2nd AC/3rd AC rail /bus fare as admissible for the post as per company rules by the shortest route from the mailing address mentioned in their application form to Cochin Shipyard Ltd, Kochi on production of proof.

- (xi) Candidates should enclose copies of certificates in proof of age, qualification, experience and caste and their candidature will be considered on the strength of those certificates and information provided in the application.
