The candidates shall have to bring Resume/CV/Bio-data along-with attested copies of relevant Certificates. The walk in interview shall be conducted on 25.06.2013 from 11.00 am to 1.00 pm at Branch Office Aurangabad on above address. Terms and Conditions

- 1. The candidate must be qualified as B Sci (Agriculture) from reputed and recognized College/ University with minimum aggregate marks of 55% (50% marks in case of SC/ST & Physically Handicapped candidates). The knowledge of computers shall be considered as an additional advantage.
- 2. The candidate must bring attested copies of relevant certificates like Birth Certificate, Caste Certificate, Education Qualification (SSC and above) Degree Certificate (issued by relevant authorities), Experience Certificate if any along-with the CV/Resume/Bio-data at the time of interview. Fresh candidates recently passed out, holding a valid degree certificate can also apply.
- 3. The maximum age of the candidate should be 27 years as on 18.06.2013 (Relaxable by 5 years in case of SC/ST, 3 Years for OBC excluding Creamy Layer, for Physically Handicapped (VH, HH & OH) 10 years (15 years for SC/ST, 13 years for OBC).
- 4. Reservation for SC/ST/OBC/Physically Handicapped persons will be provided as per Government of India's directives.
- 5. The selected candidates shall be appointed as a "**Scout**" for a period of Six months from the date of appointment on purely temporary basis on a fixed pay of Rs. 7500/- per month (Consolidated and inclusive of expenses towards field visits). The appointment will be on Contract basis and the incumbent shall not have any claim for regular appointment.
- 6. No TA/DA will be provided for appearing in the interview.
- 7. The Provident Fund / Taxes if any shall be deducted as per rules.
- 8. The selected candidate will be posted at the centre level anywhere in Marathwada / Khandesh area and shall be required to visit the fields in the nearby villages under Contract Farming program. No accommodation will be provided.
- 9. The selected candidate shall have to join within seven days from the date of issuance of the order, failing to which the order shall be treated as cancelled.

They shall have to produce all relevant certificates in original to the concerned officer for verification.
