AYUSH DOCTOR FOR MOBILE HEALTH UNIT

ELIGIBILITY CRITERIA :-

1. The candidate must have a Bachelor degree in Homeopathic Medicine and Surgery (B.H.M.S) from a recognized university.
2. S/he should have passed Oriya up to M.E. Standard.
3. Should have registered in the Homeopathic council.
4. **AGE:** The candidate should be under 37 years and over 21 years of age on 01/01/2013 and the upper age limit as prescribed will be relaxable only for the categories mentioned below.
 - a. Up to a maximum of 5 years if a candidate belongs to S.C./S.T. or women or ex-servicemen.
 - b. Up to a maximum of 3 years in the case of candidates belonging to S.E.B.C.
 - c. Up to maximum of 10 years in case of Physically challenged candidates.
