- 1. No TA/DA will be paid to the candidate for appearing in the interview. The candidates reached upto 11.00 AM on dated 02.04.2016 will be considered / allowed in the interview.
- 2. The age limit is 21 to 40 years. Upper age relaxation of five years will be given to SC & ST candidates.

- 3. Interested candidates may appear before the selection committee alongwith original certificates and one set of Photostat self attested copies of all the relevant certificates.
  - (i) Matriculation certificate (ii) BSc Nursing Certificate (iii) Higher qualification certificates and experience certificate if any (iv) Odisha bonafied certificate (v) Character certificate (vi)One attested copy of pass-port size photograph.
- 4. Preference will be given to those who have higher qualification / experienced in the required discipline and having valid experience certificate. The candidate must be bonafied Odia.
