The Science & Technology Department invites application for filling up the following honorary posts. The Last date for Receipt of the Application – **08**<sup>th</sup> **April**, **2013 by 5.00 P.M.** 

Post: 1. President, Odisha Bigyan Academy-1 (one)

- 2. Vice President, Odisha Bigyan Academy-1(one)
- 1. The President, Odisha Bigyan Academy is the ex-officio member of the Executive Council of Odisha Bigyan Academy. The President shall be appointed by the Government of Odisha and shall hold office for a term of 2 years. The President shall have the power to preside over the General Council and such other committees of which he is named a member and to take decisions on behalf of the General Council or the Executive Council when circumstances so warrant subject to ratification by the concerned authority at its next meeting.
- 2. The Vice President, Odisha Bigyan Academy is also the ex-officio members of the Executive Council of Odisha Bigyan Academy. The Vice-President shall be appointed by the Government of Odisha and shall hold office for a term of 2 years. The Vice-President shall discharge the responsibilities of the President in his absence. He shall discharge such other functions as assigned by the President on his behalf.
- 3. The appointment of President and Vice-President of Odisha Bigyan Academy shall be made by a Selection Committee as approved by the Government by inviting applications through Advertisement
- **4.** The **eligibility criteria** for the Post of President and Vice-President of Odisha Bigyan Academy are fixed as follows:
  - a. Qualification: Ph. D in any branch of Science / Engineering / Technology or M.D in Medical Science Stream. (higher qualification is preferred.)
  - b. Age: Minimum age 55 years and Maximum age 65 years as on 01.01.2013.
  - c. **Experience:** Minimum 5 years experience in the rank of Professors or equivalent post of Central / State Govt. or Scientist 'F' of the Research Institutes in Govt. of India. The candidate should indicate the measures taken by him / her in popularizing Science.
  - d. He should <u>not have any adverse remark</u> in his character <u>nor involved in any business or politics</u> (an affidavit in this context is required) and should have good health.
  - e. **Honorarium** and other benefits shall be provided to the above posts as per rules and norms of Finance Department, Government of Odisha.
