1. Applications are invited from Indian National candidates in A-4 size paper, as per specimen given alongwith attested copies of requisite certificates, testimonials, two copies of recent passport size photograph duly attested by a Gazetted Officer and self addressed envelope with Rs 05 (five) postal stamp thereon for the following vacancies / posts. Applications should reach by ordinary post to Supply Depot ASC Binnaguri, PO: Binnaguri Cantt, Distt: Jalpaiguri (West Bengal), PIN-735232 within 21 days of date of publishing of the advertisement mentioned in Employment News by DAVP. The scale of pay and specification of the posts are given below:-

2. Place of work : Supply Depot ASC Binnaguri & on all India service liability Including field service.
3. Duration/condition of post : Temporary but likely to be permanent with two years of probationary period.

Notes:-

a) All eligible candidates will be short listed on the basis of percentage of marks obtained in the examination of essential qualification. A bench mark will be fixed depending on the number of applicants. No weightage will be given for additional/higher qualification (other than those prescribed in the recruitment rules). All candidates meeting the bench mark will be invited for further test. The administration reserves the right to fix a cut-off bench mark for selection. Only short listed candidates will be called for test / interview. Candidates found primarily eligible in the physical test will be allowed for the further tests/interview. The number of candidates to be called for interview will be restricted to 10 times the number of vacancies.

b) Candidates are required to undergo / appear for physical/endurance test, written and interview and the ratio of marks 40:40:20 will be allocated respectively for the ibid test. The syllabus for written test & interview will include basic knowledge of the trade and general awareness & knowledge of matriculation level.

c) Applicants may mention their Registration No. allotted by the Employment Exchange, if any.

d) Photo copies of all documents like education, age proof, caste certificate, experience certificate, domicile/residence certificate, identity proof, character certificate (issued by Gazetted Officer in last six months) etc duly attested by a Gazetted Officer will be attached with each application form. One copy of photograph to be pasted in the application form and another in the acknowledge/admit card. Original copy of the documents will be produced by the candidate on the date of test/interview.

e) The crucial date for determination of age will be the closing date for receipt of applications. Candidates found over age on the crucial date for determination of age will be disallowed for test / interview.

f) Applications must be sent by ordinary post. Department will not be responsible for any postal delay. No application will be accepted in person / by hand, through any representative or by registered / speed post. The envelope containing the application must be clearly superscripted in bold letters with the name of the post applied for and reservation category viz. SC/ST/OBC/UR along with the reference of DAVP No. vide which this advertisement published as follows:-

g) Date & time of test / interview for the posts will be intimated later through acknowledgement/admit card by post separately to the eligible candidates whose application have been found in order. The candidates must fill column 1-4 of the acknowledgement / admit cards and attached the same with the application form. No candidate will be allowed for test / interview without acknowledgement/admit card to be issued by this office. No candidate will be allowed after the scheduled time on the day for interview / test. The candidate not in receipt of acknowledgement-cum-admit card should presume that their application were incomplete/not meeting QR/ benchmark, found ineligible or received after due date. Overwriting /erasure/incorrect/incomplete information and documents with application form will result in rejection of the application. No representation or correspondence in this regard will be entertained. Medium of writing in application form and test will be Hindi or English only.

h) 440 Coy ASC (Sup) / Supply Depot ASC Binnaguri will not be responsible to pay any damages in case of any injury/accident of candidate during physical test.

j) No travelling allowance will be admissible for the test/interview. Candidate will arrange for lodging & food at their own as the process may take more than two days.

k) In case of OBC, the caste certificate, inter-alia must specify that the candidate does not belong to ‘creamy layer’; certificate for OBC should be in conformity with the Govt rules.

l) Merely fulfilling the basic selection criteria does not automatically entitle a person to be called for test/ interview.

m) The number of posts / vacancies is tentative and is subject to decrease / increase. 440 Coy ASC (Sup)/Supply Depot ASC Binnaguri reserves the right for cancellation of the recruitment process/ extension of dates without assigning any reason at any stage and the decision in this regard is final and no appeal will be entertained.

n) Any attempt by any candidate to influence the selection process may result in disqualification of the candidate from taking further part in the selection process.

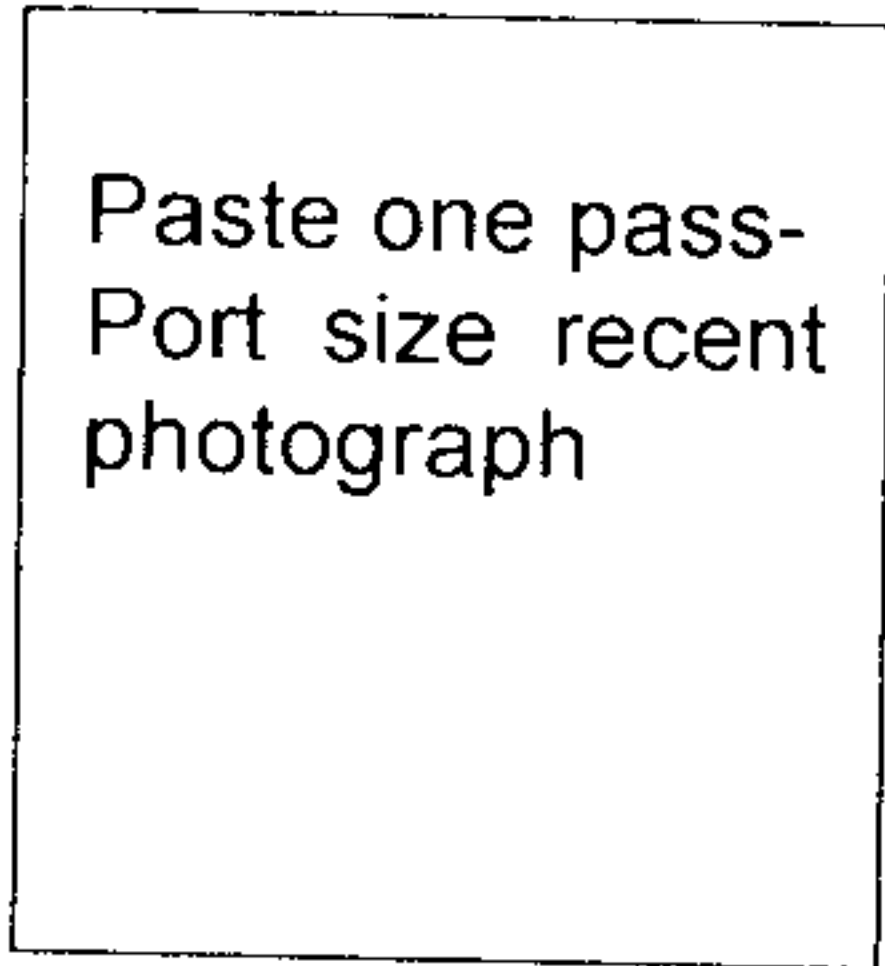
