RECRUITMENT OF ASSISTANT MANAGERS

Rajasthan Financial Corporation (a Public Financial Institution established in 1955 as per Central Enactment, namely, SFCs Act, 1951) offers career opportunities for young, dynamic & professionally qualified candidates for the post of Assistant Manager (IT-7, Law-3, Technical-2 & Chartered Accountant-1) from among those who qualified in the **Combined Result for CWE & Interview for Recruitment of Specialist Officers (CWE SPL-II)** for either of the Scales (i.e. Scale-I or Scale-II) issued by the Institute of Banking Personnel Selection (IBPS) for the Specialist Officers Common Written Examination – II (Specialist Officers CWE-II) Exam held on 16th & 17th March, 2013 and interview conducted subsequently. The first priority in order of merit shall be given to the candidates of Scale-II (wherever applicable) and after exhausting the list of Scale-II the candidates of Scale-I will be considered for appointment.

The candidates declared selected will be appointed as Assistant Managers. After successful completion of probation period of two years they will be placed in the Pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4800/- plus other allowances (as per norms of the Corporation). Present gross monthly emoluments at the minimum of the Pay Scale are Rs. 31,000/-approx.(including Pay in Running Pay Band, Grade Pay, D.A., H.R.A., CCA, Corporation contribution to PF) . During probation period, they will be paid fixed remuneration @ Rs. 15,000/- p.m.

Eligible candidates may apply on-line to Rajasthan Financial Corporation (www.rfc.rajasthan.gov.in) w.e.f. 12.08.2013 to 27.08.2013.

GENERAL TERMS AND CONDITIONS

- a) If a candidate is short listed for joining the Corporation his/her candidature to further re-use of the same score to apply to any other organization will be nullified and the candidate will NOT be considered for any subsequent round(s) of allotment based on CWE Spl II in PSBs or other organisations.
- b) The candidates who have qualified in the **Combined Result for CWE & Interview for Recruitment of Specialist Officers (CWE SPL-II)** online exam held on 16-17th March, 2013 and subsequent interview and not allotted to any organization by IBPS are only eligible to apply.
- c) Candidates are required to apply online through website www.rfc.rajasthan.gov.in. No other means/mode of application will be accepted
- d) Candidates working in Govt./Semi-Govt./Public Sector Undertakings will be required to produce No Objection Certificate from their employer, if called for joining, in the absence of which, his/her candidature may not be considered.
- e) In case, it is detected that a candidate does not fulfill the eligibility norms and/or that he/she has furnished any incorrect/false information/certificate/documents or has suppressed any material fact(s), his/her candidature will stand cancelled. If any of these shortcoming/s is/are detected even after appointment, his/her services are liable to be terminated.
- f) All candidates will have to produce copy of the online application submitted to IBPS for CWE for recruitment of Specialist Officers alongwith original as well as attested photocopies of certificates regarding Qualification. Essential Requirements i.e. Date of Birth and Caste (if applicable), in support of their eligibility at the time of joining, failing which their candidature will be cancelled.
- g) In case of candidates belonging to OBC category, the certificate inter-alia must specify that the candidate does not belong to "CREAMY LAYER" section excluded from the benefits of reservations for OBCs in Civil Post and Services under Govt. of India / Govt. of Rajasthan and the certificate should contain the "NON-CREAMY LAYER CLAUSE" which should not be more than one year old.

- h) Appointment of selected candidates is subject to his/her being declared medically fit as per the requirement of the Corporation. Such appointment will also be subject to the provisions of Rajasthan Financial Corporation (Staff) Regulations, 1958.
- i) The candidates who apply for the post of Assistant Manager will be given appointment only on the post of Assistant Manager in the prescribed/applicable pay scale of Assistant Manager of the Corporation irrespective of their being qualified for Scale-I or Scale-II.
- j) Chairman & Managing Director, Rajasthan Financial Corporation will have the absolute authority to accept or reject the application of any candidate without assigning any reason.
- k) Common seniority list is being maintained by the Corporation for all cadres including Assistant Managers irrespective of their discipline i.e. IT, Technical, Law, Finance etc.
- l) RFC(Staff) Regulations, 1958 as amended from time to time will be applicable to the officers so recruited and appointed."
