Advertisement for engagement of contractual Accountant-cum-Data Entry Operators in Gram Panchayat under the RGPSA Scheme.

Applications in the prescribed format (given below) are invited from the eligible candidates for contractual engagement of Accountant-cum- Data Entry Operators to be engaged at the Gram Panchayat Level with a consolidated remuneration of RS. 5,200/- per month under the centrally sponsor scheme Rajiv Gandhi Panchayat Sashaktikaran Abhijan (RGPSA).

## 2. Eligibility Criteria:

- a. He/She must be a Citizen of India.
- b. He/She must be a permanent resident of District.
- c. He/She must have passed +2 Examination in any discipline with minimum knowledge in computer operation. However, first preference shall be given to the candidates having +2 Commerce, second preference to +2 Science and Later to +2 Arts.
- d. The applicant must not be below 18 years and above 32 years age as on 01.01.2014.
- e. He/She must be of good character.
- f. He/She must be of sound health.
- g. He/She is able to read, write and speak Odia.
- h. He/She, if married has not more than one spouse living.

#### 3. Application Fee:

Each applicant has to pay the application fee as prescribed below in shape of Bankers cheque/ Demand draft drawn in any nationalized bank in favour of the Project Director, DRDA, Sundargarh and Payable at State Bank of India, Sundargarh. Applicant has to sign on the reverse side of the Bankers cheque/ Demand draft and has to attach it with the application.

- i) Candidates belong to Unreserved category:- Rs. 200/- (Rupees Two hundred).
- ii) Candidates belong to ST/SC/SEBC category:- Rs. 100/- (Rupees One hundred).

#### 5. How to apply:

Application in the prescribed form along with required documents shall be submitted to the District Panchayat Officer, Sundargarh, At/PO- Sundargarh, Dist-Sundargarh, Pin- 770001 in an envelope superscribed as "APPLICATION FOR THE POST OF CONTRACTUAL ACCOUNTANT-CUM-DATA ENTRY OPERATOR (RGPSA)" by Registered Post / Speed Post / in person only on or before 20.02.2014. The Application form will not be received after 5 p.m. of 20.02.2014 in the office of the District Panchayat Officer, Sundargarh. The authority will be no way responsible for any postal delay or loss in transit. Application received in any other format or by any other means or incomplete in any other respects will not be accepted.

A receipt as a token of acknowledgement shall be issued by the office of the District Panchayat Officer, Sundargarh while receiving the applications by hand.

#### 6. Selection Process:

a. Selection of candidates would be on the basis of marks secured in HSC and +2 Examination. The 50% of percentage marks secured in HSC Examination and 50% of percentage marks secured in +2 Examination (Excluding 4<sup>th</sup> Optional) will be added to draw up the merit list of candidates.

b. Applicants with +2 Commerce qualification will be preferred over the applicants having +2 Science or +2 Arts qualification. If no applicant with +2 Commerce qualification is available, then the applicant having +2 Science qualification will be preferred over the applicants having +2 Arts qualification.

c. If a Gram Rojgar Sevak (GRS) of the same Gram Panchayat with required qualification applies for the post, then the following procedure shall be followed for selection of Accountant-cum-Data Entry Operators:

I. If a Gram Rojgar Sevak (GRS) of the same Gram Panchayat having +2 Commerce qualification applies for the post then he will be preferred over the other new applicants having required qualification, irrespective of the marks secured by the GRS.

II. If a Gram Rojgar Sevak (GRS) of the same Gram Panchayat having +2 Science qualification applies for the post then the new applicant with +2 Commerce qualification shall be selected. If no new applicant having +2 Commerce qualification is available then the GRS will be preferred over the new applicants having +2 Science or +2 Arts qualification.

III. If a Gram Rojgar Sevak (GRS) of the same Gram Panchayat having +2 Arts qualification applies for the post then the new applicant having +2 Commerce of +2 Science qualification shall be selected. If no new applicant with +2 Commerce or +2 Science qualification is available then the GRS will be preferred over the new applicants having +2 Arts qualification.

d. The candidates belonging to the Gram Panchayat concerned shall be given preference. If no candidate is available within a Gram Panchayat, the post will be filled up by selecting candidates available within the concerned Block. If no candidate is available within the Block, the posts will be filled up by selecting candidates available within the District.

e. The list of successful candidates will be drawn up in order of merit and will be published in the District website.

f. Inclusion in the merit list does not necessarily confer the right for engagement.
