National Security Guard (NSG) proposes to engage Specialist Medical Officers in the followings posts for Composite Hospital, NSG at Manesar (Gurgaon), Haryana (purely on contract basis) as per the terms and conditions mentioned below:-

i) Surgeon	:	01 Post
ii) Anaesthesia	:	01 Post
iii) Ophthalmologist.	:	01 Post

The terms and conditions for the said posts are given as under:-

1. **Remuneration:** Rs. 57,672/- consolidated per month. The contractual appointee will not be entitled to any other allowances, benefits or concessions as admissible to Govt. Employees.
2. **Age:** The maximum age limit is 65 years. The Specialist Medical Officers appointed on contract will not continue on the post once he/she reaches 65 years of age.
3. The appointment will be purely on contractual basis for a period of three years or till the appointee attains the age of 65 years or till the regular incumbent joins, whichever is earlier. Thereafter, the contract will lapse automatically. However, the appointment can be terminated at any time by giving one month's notice (on either side) without assigning any reason by paying/refunding one month's salary. The selection is purely contractual in nature and does not carry any right for regularization or permanent absorption. No extension beyond the stipulated three years will be given. However, such an contractual appointee can apply again afresh on completion of 3 years tenure.
4. No TA/DA is admissible for the interview. Suitable and willing candidate may WALK IN FOR INTERVIEW on 18/06/2014 at 1100 hours at NSG Head Quarters, Mehram Nagar, Palam, New Delhi-37 as given in Newspaper/Rozgar Samachar along with original and photocopies of all relevant documents (like Graduate degree, Internship completion certificate, age proof and experience certificate and application in plain paper superscripting the name of the post applied for and five recent passport size photographs.
5. The Competent authority reserves the right for any amendment, cancellation and change in this advertisement in whole or part thereof without assigning any reason.
6. **Medical Examination.** The selected candidate will undergo medical test as prescribed for regular appointment.
7. The appointment will be subject to verification of character and antecedents.
8. The appointee shall perform the duties assigned to him. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowance will be admissible in case of such assignment.
9. The appointee shall not be entitled to any benefits like provident Fund, Pension, gratuity, medical attendance treatment, seniority, promotion etc or any other benefits available to the Government Servant appointed on regular basis.
10. Non practicing allowance will not be admissible.

11. The appointee shall not have any claim or right to regular appointment to any post under CAPFs.
12. The appointee shall be on whole time appointment to Composite Hospital, NSG and shall not accept any other appointment, paid or otherwise, during the period of contract.
13. The appointment carries with it the liability to serve in any part of the country.
14. Appointment is subject to the physical fitness from the competent Medical Board for which he will be sent to the designated Medical Authority every year.
15. The appointee is required to submit a declaration regarding his/her marital status.
16. On appointment, the appointee will be required to take on oath and allegiance to the Constitution of India and make a solemn affirmation to the effect in the prescribed proforma.
17. The appointee will not be entitled for any TA/DA for joining the appointment.
18. Other conditions of contract will be governed by the relevant rules and orders issued from time to time.
19. If any declaration or information given by him/her is found to be false or if he/she is found to have willfully suppressed any material information, he/she will be liable to be removed from service and any such other action as the Govt may deem necessary.
