TERMS AND CONDITIONS AND NATURE OF DUTIES:

1. FIELD SUPERVISORS

1. Engagement Terms:

- a. The engagement of Field Supervisor shall be for a period of one year and renewable, if required, on successful satisfactory report of the Field Supervisor and this engagement shall be for the project/scheme whichever is earlier.
- b. The services of Field Supervisor can be terminated before the contract period without any prior notice, if mis-conduct, poor performance on his part is observed.
- c. In case of Field Supervisor has to leave his consultancy job before contract period he has to give two months' prior notice or to deposit two months' emoluments in lieu of notice.
- d. He will be given 10 days proportionate leave during the contract period.

2. Payment Terms:

Payment terms and other facilities should be as follows:

- i. Consolidated emoluments Rs.9800/- per month as per D.C. rates.
- ii. Actual travelling allowances within India as approved by MD, HSHDA as per the exigencies of work.
