Applications are invited in the prescribed format for the vacant and likely to be vacant posts of Senior Resident (Ophthalmology), & Senior Resident (Anesthesia) in Guru Nanak Eye Centre under residency scheme on regular basis from all interested eligible candidates as per details given hereunder;

1. ELIGIBILITY:

A. EDUCATIONAL QUALIFICATION

MBBS with P.G. Degree/Diploma/DNB in the concerned specialty from a recognized University/Institution and should have a valid registration with Delhi Medical Council / Fee deposition receipt for registration in DMC on last date of submission of application form. Must have not completed 03 year Senior Residency in any recognized institution including regular & adhoc period.

B. AGE LIMIT

- (i) 33 YEARS for Senior Residents as on last date of submission of application form, 05 years age relaxation is allowed for SC/ST and 03 years for OBC candidates.

C. EMOLUMENTS:

- (i) Pay Scale: PB-3 of Rs. 15600-39100+Grade Pay Rs. 6600/- plus allowances as admissible under the rules.

Note:

1. In case of Non Availability of reserved candidates, the vacant post shall be filled up for 89 days on adhoc basis from the panel of selected candidates under General category.
2. The number of vacancies may vary.

3. The Senior Resident (Anesthesia) will work as per roster maintained in Anesthesia department, Lok Nayak Hospital, New Delhi. They will draw salary from Guru Nanak Eye Centre, New Delhi and the certificate of experience will be granted by Guru Nanak Eye Centre i.e Senior Resident (Anesthesia) will be under Administrative control of GNEC but will work as per roster of Lok Nayak Hospital (as per mutual understanding by both the hospitals and approval of H&FW Department, Govt of NCT of Delhi.)

Further, in case of non-availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of the relaxation of provision circulated as per circular No. F. 121/26/2010/H&FW/1996-2045 dated 10/6/2011 of Deptt. of H&FW GNCT of Delhi with the following relaxations:-

- (i) Upper age limit for eligibility under relaxation will be 40 years.
- (ii) In the specialties where there is perpetual shortage like anesthesia and radiology etc. or in specialties where no fresh candidates are available, candidates who have completed 3years of Sr. Residency may also be allowed to appear in the interview.
- (iii) Separate merit lists for fresh candidates and for others (those who have completed 3 years of Sr. Residency already) would be prepared.
- (iv) Firstly, the list containing the names of fresh candidates would be exhausted for appointment as Senior Residents and the second list would be used only after that.
- (vi) All Senior Residents appointments from second list will be for one year only. It would not be renewable after one year.

2. FEE PAYABLE FOR THE POST OF SENIOR RESIDENT:

Rs. 500/- for General & OBC candidates in the form of Demand Draft issued in favour of **“Director, Guru Nanak Eye Center, New Delhi” payable at New Delhi. (Non refundable).** SC/ST Candidates are exempted from payment of fees.

3. OTHER TERMS AND CONDITIONS FOR ENGAGEMENT

- The appointment will be initially for one year that can be extended further up to 3 years on annual basis for Senior Residents subject to satisfactory performance and work and conduct. The service conditions will be regulated as laid down in the residency scheme. Appointment will be subject to Medical Fitness / verification of Testimonials & Character & Antecedents report.
- Inter hospital transfer is not permissible, however appointing authority reserves the right to transfer services of Sr. Resident within the Hospital.

4. Schedule of selection process:

- **Last Date of submission of application** complete in all respect will be **06.07.2015 by 3.00 PM**
- **Display of eligible candidates for appearing in selection process** will be **13.07.2015 at 03:00 PM**
- **The written test & interview for Senior Resident (Ophthalmology)** will be conducted on **16.07.2015 from 09:00 AM onwards.**
- **Interviews for senior Resident (Anesthesia)** will be conducted on **17.07.2015 at 02.00 PM.**

All the eligible candidates for Senior Resident (Ophthalmology) post should reach the venue on time for written test alongwith all original certificates i.e certificates of Educational Qualification / Date of Birth / Caste / DMC registration. Internship completion certificate / MBBS Degree with mark sheet, presentations, publications and awards etc. and their self attested photocopies and three recent passport size photographs with them.

- **Final List of successful / selected candidates will be displayed on the notice board in front of Room No. 32 on 20.07.2015 at 03:00 PM.**

NOTE:-

- (1) The duly filled application, in prescribed proforma annexed below, should reach the **Director's office at Room No. 32, Guru Nanak Eye Centre, Maharaja Ranjit Singh Marg, New Delhi – 110002** upto **06.07.2015 by 03:00 PM.** along with attested copies of all the relevant certificates regarding educational qualification including marks sheets, experience, DOB, Mark-sheet of MBBS, Internship completion certificate, Caste Certificate, DMC Registration Certificate, PG Degree / Diploma attempts certificate etc. Incomplete applications will be rejected straightway and no further correspondence will be made in this regard.
- (2) **The benefit of reservation against vacancies reserved for OBC shall be given only to those candidates whose state of origin is in NCT of Delhi & his/her caste covered in the approved list of OBC of NCT of Delhi in terms of the conditions laid down in the circular No. BC/2025/2/76-SCT(1) dated 22.03.1973 of Ministry of Home Affairs, Govt of India. (This is, however, subject to the decision of the Hon'ble High Court Delhi in LPA No. 625/2002) and the OBC certificate of NCT of Delhi.**
- (3) No TA / DA is admissible for appearing in the interview / written test.
- (4) Canvassing in any form is strictly prohibited and will make the candidate ineligible.
- (5) Director, GNEC reserves the right to amend, cancel or postpone the selection process without citing any reasons thereof.
