- A minimum of ten years of teaching experience in university/college, and/or experience in research at the University/National level institutions/industries, including experience of guiding candidates for research at doctoral level.
- Contribution to educational innovation, design of new curricula and courses, and technology-mediated teaching learning process.
- A minimum score as stipulated in the Academic Performance Indicator (API) based Performance Based Appraisal System (PBAS), set out in UGC Regulation in Appendix III.

OR

- B. An outstanding professional, with established reputation in the relevant field, who has made significant contributions to the knowledge in the concerned/allied/relevant discipline, to be substantiated by credentials.

## 2. Director, Regional Centre

- (i) Good academic record with a Ph.D Degree 1- the concerned/allied/relevant disciplines.
- (ii) A Master's Degree with at least 55% marks for an equivalent grade in a point scale wherever grading system is followed)
- (iii) A minimum of eight year of experience of teaching and/or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry excluding the period of Ph.D research with evidence of published work and a minimum of 5 publications as books and/or research/policy papers.
- (iv) Contribution to educational innovation, design of new curricula and courses , and technology-mediated teaching learning process with evidence of having guided doctorat candidates and reseach students.

## 5. Assistant Professor in Chemistry

- (i) Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET.
- (iii) Notwithstanding anything contained in sub-clauses (ii) to this clause candidates, who are, or have been awarded a Ph.D Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D Degree) Regulation, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in University/College Institutions.

**Note :-** "Good Academic Record" should mean atleast Second Division with atleast 55% marks from Board Examinations upto the graduate level i.e. Secondary/High School, Senior Secondary/Higher Secondary/Intermediate and Graduation ( As per Government of Rajasthan letter No. F3(2)Edu./4/99 Jaipur , dated 11-03-2002.)


## Other Terms and Conditions

1. Candidates can apply Online for various posts from 08-06-2015 to 24-06-2015
2. A separate application should be submitted for each post.
3. Candidate should remit a sum of Rs. 1000 ( For SC/ST/Persons with Disability (PWD) or Physically Challenged (PH) candidates Rs. 500/-) Online fee may be remitted via E-Mitra/Net Banking/ Debit Card /IMPS while filling the Online Application Form.
4. Those already employed should apply through proper channel. However, they may submit a No Objection Certificate with printout of the prescribed form filled online by candidate on or before the deadline set for receiving the applications. Retired persons need not apply.
5. The qualifications, emoluments and conditions of service, including age of superannuation, pension shall be as prescribed by the Government of Rajasthan/VMOU from time to time.
6. The printout of prescribed form filled online alongwith necessary enclosures must be dispatched by **Registered or Speed Post Only** to the office of the **Registrar, Vardhman Mahaveer Open University, Rawatbhata Road, Kota (Rajasthan)-324021** and should reach on or before 30-06-2015
7. Any candidate, who has more than 2 children on or after 01/06/2002 will not be eligible. Provided further that the person having more than two children shall not be deemed to be disqualified for appointment so long as the number of children he/she has on 1<sup>st</sup> June, 2002, does not increase. Provided further that where a candidate has only one child from the earlier delivery but more than one child are born out of a single subsequent delivery, the children so born shall be deemed to be one entity while counting the total number of children.
8. The selected candidate will be appointed as 2 years or 01 year (As per State Govt. Rules) probationer trainee. A fixed remuneration will be paid during the period of probation training as per State Government notifications. No other allowances will be during this period. The pay band & grade pay of such posts shall be permitted from the date of completion of probation training period satisfactorily as per rules.
9. Candidates are advised to satisfy themselves before applying about the fact that they possess at least the minimum essential qualifications laid down in the advertisement.
10. The selection procedure for the above posts shall be as approved by the Board of Management of the university.
11. Experience and qualifications will be reckoned as on last date of submission of application i.e. on 30-06-2015 **Clear quality self attested photocopies (from Xth onwards) of all important documents related to qualifications, experience and other related submissions must be attached with the application.**
12. No TA/DA shall be paid to the candidates for attending written test as well as the interview.
13. Application fees once paid shall not be refunded under any circumstances.
14. The University will not be responsible for postal delay in receipt of the application forms from the candidates.
15. Applications (i) received after the last date (ii) incomplete in any respect, (iii) not accompanied by copies of the required documents, and (iv) any fresh paper/enclosures submitted after closing date, may not be considered.
16. Certificate in support of experience should be in proper format i.e. it should be on the organization's letter head, bear the date of issue, indicate specific period of work, name and designation, pay band with AGP etc. issued by the employer.
