5. Last date of receipt of application is 17/01/2015 by 16.30 Hrs. Application forms received after the given date will be rejected. Date and Time for Exam / Interview will be intimated to the individual by post.

6. The crucial date for determining the age limit shall be the last date of receipt of application.
