## GRADE IV (DASS) IN SERVICES DEPARTMENT UNDER POST CODE 61/2015

The DSSSB vide its advertisement No 01/2015 with closing date 26/11/2015 and addendum dated 15.09.2017, had advertised **1025 vacancies (UR-504, OBC-117, SC-162, ST-242 including PH-26(OH-10, HH-08, VH-08), Exsm-81, SP-40)** for the post of Grade IV (DASS) in the Services Department under Post code 61/2015. Board has conducted One Tier written examination for recruitment to this post on 17.09.2017.

Marks of the candidates have been uploaded on Board's website. Based on the performance in One Tier written examination, **3086 (three thousand eighty six) candidates**, as detailed below, have been provisionally shortlisted to appear in typewriting skill test in the ratio of 1:3 ratio subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application forms.

The short listed candidates shall be called for typewriting skill test separately. All the candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in.

As there were no separate distinction of subcategory of PH was available indicating the PH candidate belongs to OH/VH/DD, as such the ratio of 1:5 ratio subject to attaining minimum qualifying marks has been considered in case of PH category.

The OMR sheets of 428 candidates, who appeared in examination for above said post code, have not been evaluated due to various reasons such as writing of roll number of absent candidates or due to wrong bubbling of roll number/question booklet series or duplicate roll number etc.

The marks of the candidates having roll number 15457602, 15457603 & 15457604 who were provisionally allowed to appear in one tier examination in pursuance of court orders - dated 12.09.17 in OA No 3139/17 & dated 15.9.17 in OA No 3256/17, have been withheld till the outcome of said cases.

The candidates shortlisted for appearing in typewriting skill test is purely provisional, subject to verification of credentials for determination of eligibility for the post to be carried out by the Board at the time of declaration of final result.

The reservation benefits under OBC category have been provided to only those candidates who have declared in their online application forms against the column "Caste Certificate Issuing State" as Delhi.

Aforesaid, reserved category candidates shortlisted in UR category in written examination, who had obtained marks above or equal to the last qualified UR candidates have been declared qualified for appearing in for typewriting skill test against UR vacancies and their final selection to the post shall be considered in UR category, subject to availability of vacancies, otherwise for selection in their respective category.

As per the Board notice dated 26.04.2013, the minimum qualifying marks in one tier written examinations for General candidate is 40% for OBC candidate is 35%, for SC/ST/PH candidate is 30% and for EXSM candidate is 5% relaxation in their respective categories subject to a minimum of 30%.

The number of qualified candidates for appearing in typewriting skill test has been done in the ratio 1:3 of the advertised vacancies, with taking all the candidates who have scored marks equal to the cut off marks for each category for short listing, subject to scoring the marks above minimum cut off marks. Final selection against advertised vacancies shall be made in accordance with the merit list drawn as per result of the written examination subject to availability of vacancies and the candidates qualifying the Tier-II examination and also fulfilling of all the conditions of eligibility as prescribed in the RRs of the post and terms and conditions of the advertisement.

While every care has been taken in preparing the result, DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
