4. Scale of pay: - Pay PB-2 (Rs.9, 300 - Rs.34, 800) + Grade Pay Rs.4800/- plus allowance as admissible from time to time.

#### Eligibility Criteria

- a) Educational Qualification: (i) B. Sc. (Nursing) or Senior Nursing and Midwifery certificate with Diploma in Public Health Nursing from a recognised Training Institute. Working Knowledge of Hindi and Bengali preferable.
- b) Age limit 18-35 years. Relaxable for Government Services up to 45 years in accordance with instructions or orders issued by the Central Government.

Note: - The crucial date for determining the age limit shall be the closing date for receipt of the applications from candidates in India (other than those in Assam Meghalaya Arunachal Pradesh Mizoram Manipur Nagaland Tripura Sikkim Ladakh Division of Jammu & Kashmir State Lahaul & Spiti district and Pangi Sub Division of Chamba District of Himachal Pradesh Andaman & Nicobar Iskands of Lakshadweep) which will be 30 days from the date of publication of advertisement.

In respect of post, the appointment to which is made through the Employment Exchange the crucial date for determining the age limit shall be the last date up-to which the Employment Exchange are asked to submit the names.

#### **General Conditions and instructions**

- It is made clear that mere fulfilling the minimum prescribed qualifications and experience will not
  vest any right in a candidate for being called for interview. In case the number of applications would
  be too large and not be practical to hold interview for such a large number, after completion of the
  process of screening of the applications, short-listing of applicants will be done in order of merit by
  giving preference to those who process higher qualifications, experience and call letters will be sent
  to the applicants.
- 2. The decision of the Director regarding acceptance/rejection of application will be final and no correspondence will be made on rejection of the application.
- 3. In case of departmental candidates with 3 years continuous service, upper age limit will be relaxable up to 45 years, subject to the condition laid down in the DOPT OM No.15012/1/88-Estt. (D) dated 20-05-1988 that the direct recruitment post is in the same line or allied cadre and a relationship could be established that the services already in a particular post will be useful for the efficient discharge of the duties of the post advertised/circulated.

- 4. Canvassing in any form by or on behalf of candidates or to bring political or other outside influence with regard to selection/recruitment will be considered as disqualification and candidature of such candidates is liable to be summarily rejected. No enquiry or correspondence will be entertained.

Degree/Diploma etc. obtained through open Universities/Distance education mode will not be accepted for the purpose of educational qualification unless it is recognised by Distance Education Council in terms of Min. of Human Resource Development Notification No.44 dated 01/03/1995 published in Gazette of India dated 08/04/1995 for the relevant period when the candidate acquired the relevant qualification.
