ORDER:-

Note:-

- 1.The selected candidates are informed that their appointments are purely on temporary basis and they are liable to be terminated at any time without assigning any reasons.
- 2.The selected candidates shall join the post within 30 days from the date of despatch of these proceedings. If any candidate doesnot join the post within the stipulated time of 30 days, these appointment proceedings shall be treated as automatically cancelled. Any request from the candidates for extension of time to join duty will not be considered. They are directed to produce all original certificates of their Educational Qualifications, Proof of Date of Birth, Caste Certificate etc., at the time of joining duty.
- 3.At the time of joining duty; the above individuals shall produce Physical Fitness Certificate issued by a Medical Officer not below the rank of Civil Surgeon.
- 4.The individuals appointed after 1-9-2004 are only covered by the Contributory Pension Scheme and the pension scheme under A.P.Revised Pension Rules, 1980 will not be applicable to them as per G.O.Ms.No.653, 654 and 655 Finance (Pension-I) Department, Dated 22-9-2004.
- 5.The interse-Seniority of the newly selected candidates will be fixed as per the directions of the Hon'ble High Court 3rd read above and neither the seriatum mentioned in these proceedings nor the dates of joining of the individuals is a criterion to determine their seniority. These proceedings do not affect the seniority of the other selected candidates whose antecedents are awaited.
- 6.The regular employees who are transferred at their request are not entitled for any T.A or joining time.
- 7.The Officers concerned are required to relieve the above individuals with a direction to join in their new posts on or before..8..8...16
- 8.The orders are placed in the Official Website of Prakasam District and the downloaded copy is valid for relieving and reporting of the employees.
- 9.The Officers are instructed not to entertain any leave applications/retention applications of the employees who are transferred.
