ORDER NO:- 81 - B of 2017

DATED:- 06-02-2017

1. Whereas, pursuant to Order No.36-B of 2017 dated:- 12-01-2017, a select list of 07 (Seven) candidates for the posts of Jr. Assistant in the payband of Rs.5200-20200 Grade Pay of Rs.1900/- of open and RBA candidates was issued by operating waiting list of the main selection list notified vide order No.548-B of 2016 dated:- 10-12-2016.
2. Whereas, the selected candidates were required to join within 21 days from the date of issue of their appointment orders failing which their appointment was liable to cancellation ab-initio.
3. Whereas, Mr. Mukul Jandiyal S/O: Mr. Karam Vir Gupta, R/O: 2/113, Vikas Nagar Sarwal-Jammu who was selected as Junior Assistant out of the wait list vide order No.36-B of 2017 dated:- 12-01-2017, failed to Join the Board service within stipulated period of joining time and has also furnished an affidavit stating therein that he is not willing to Join Board services.
4. Whereas, one more candidate namely Mr. Ved Parkash, who was selected at serial no.30 in the main selection list resigned from the Board services immediately after joining and his resignation has been accepted vide order No.30-B of 2017 dated:- 09-01-2017.

Now therefore, the appointment of Mr. Mukul Jandiyal S/O: Mr. Karam Vir Gupta, R/O: 2/113, Vikas Nagar Sarwal-Jammu, as Jr. Assistant is hereby cancelled.

Consequent upon above, sanction is hereby accorded to the appointment of following two candidates out of waiting list of the main selection list, as Junior Assistants in the pay band of Rs.5200-20200 G.P=1900 with immediate effect, against the available posts in **Open category**.

The appointees are required to join and report to the Joint Secretary Administration, Jammu Division, within 21 (Twenty One) days from the date of issuance of this order and its publication in the News papers, failing which the appointment of such candidates shall be treated automatically cancelled without any further notice.

The appointees shall be on probation for a period of two years.

The appointees shall be allowed to join only after submission of following certificates in original:-

1. Date of birth certificate (10th Class).
2. Academic Qualification Certificates of each Examination.
3. Certificate from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under the self-employment scheme has been taken by the appointees.
4. Permanent Resident Certificate issued by the Competent Authority.
5. Health Certificate issued by concerned Chief Medical Officers.

The appointment of the candidates as Junior Assistants shall further be subject to the following conditions:-

- I. Both the appointees shall give an undertaking duly attested by the First Class magistrate in the shape of an affidavit to the effect that in case adverse report about their character and antecedents is received from Inspector General of Police (CID), J&K, to whom a reference shall be made by the Joint Secretary Administration-JD, the candidate/s shall have no right to claim their appointment as Junior Assistant and the appointment, as such, shall be deemed to have been cancelled ab-initio.

forged, the appointment shall be cancelled ab-initio. The verification of certificates shall be carried out by the Joint Secretary Administration-JD, after completion of required formalities in this regard like realization of prescribed verification fee from the appointees.

- III. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of (i) and (ii) above are received in their favour.
- IV. The appointment of the said appointees shall be governed by the "New Pension Scheme" as per SRO 400 of 2009 dated:- 24-12-2009.
- V. The inter-se-seniority of the appointee(s) shall be strictly as per their merit in the select list.
- VI. The pay of the appointees in the pay band of Rs.5200-20,200 G.P=1900, shall be fixed and drawn, strictly as per the relevant rules governing the pay fixation of fresh appointees.
- VII. The appointment of the candidates to the posts of Jr. Assistants shall be subject to outcome of writ petition SWP No.1271/2016 pending disposal in the Hon'ble J&K High Court at Srinagar.
