General Instructions:-

1. Application received after due date shall not be entertained. This Directorate will not be responsible for any sort of delay caused due to postal service.
2. The post is temporary, non-government and non-pensionable under ICAR & will be governed by New Pension Scheme introduced by Govt. of India w.e.f. 1-1-2004 mutatis mutandis and as amended from time to time.
3. Interested candidates must apply in the following format & enclose the attested copies of Educational Certificate, Caste Certificate and Domicile Certificate etc. which are necessary.
4. Incomplete application in any form shall not be entertained.
5. Candidates already in service will have to send their application through proper channel and will have to submit no objection certificate at the time of interview.
6. The post is temporary but likely to continue in future. Present posting place is Mukteshwar (Nainital) but can be transferred anywhere in India.
7. The envelope containing the application form should be super inscribed "(Application for the post of Skilled Supporting Staff)" should be clearly indicated on the top of the envelope.
8. Application form complete in all respects along with application fee (Non-refundable) of Rs. 100/- (Rupees one hundred) only in the shape of D.D. in favor of "ICAR, Unit-PDFMD" Mukteshwar, payable at SBI Mukteshwar (Code 2582). Admn. Officer, PD on FMD, IVRI Campus, Mukteshwar, Nainital- 263 138 Uttarakhand, within due date, i.e. within 30 days from date of publication of advertisement in Employment News by post. (No. fee for SC, ST & Women candidates and SC/ST candidates will be paid 2nd class Train/Bus fare by the shortest route for interview).
9. Only those candidates shall be called for the interview whose application shall be recommended by the screening committee constituted by Project Director.
10. Project Director, PD on FMD reserves all the rights to increase or decrease the number of vacancies, change any of the conditions, change the dates of test/interview, rejects any or all applications and not to fill up the post at any time without assigning any reason thereof, whatsoever.
11. No age relaxation is allowed to SC/ST/OBC candidates against un-reserved posts. Even if they qualify for such post where only UR vacancies exist, they will be rejected on age ground if they do not fulfill the UR age criteria. In the same way if SC/ST/OBC candidates' qualify in the UR merit list but they do not fulfill the UR age criteria, they will be adjusted against their respective quota vacancies, if available.

13. All the dispute/ litigation, if any, will be subject to Nainital (Uttarakhand) jurisdiction only.
