

PRESS RELEASE

Recruitment to the posts of SCT Police Constables(Civil & AR) Men & Women in the Police Department and Warders (Male & Female), was notified vide Notification Rc.No.202/R&T/Rect.2/2016, dt:22-7-2016. The last date for submission of the online application was on 21-09-2016 up to 1700 hours. The Preliminary Written Test for the said posts will be held on **06-11-2016** at various locations **from 10.00 AM to 01.00 PM.** Candidates will be able to download their Hall Tickets from 25-10-2016 i.e., 10 days before the Preliminary Written Examination, by logging on to website **recruitment.appolice.gov.in**

2. The candidates were given option to select any of the three languages i.e., Telugu, English or Urdu as their medium of writing examination. 3,86,759 candidates have opted for Telugu, 46,976 candidates have opted for English and 215 candidates have opted for Urdu to write the Preliminary Written Examination.

Edit option will be given to make corrections other than the above 6 fields who comes for attending Physical Measurements Test/Physical Efficiency Test after qualifying Preliminary Test only.
