- The Commission shall have full discretion to make appointment against all or one of these posts in any manner and Commission's decision in this regard shall be final.
- (a) Minimum age limit for the posts advertised is 18 years and the maximum age will be as following:
 - Backward Class/ Extremely Backward Class 40 Yrs.

 (Male and Female)
 - Scheduled Castes/Scheduled Tribes 42 Yrs.
 (Male and Female)
 - (b) Maximum age for retired candidates should be 64 years on the last date of submission of application.
- 3. (a) Retired persons shall be appointed initially for one year which may be extended as per requirement for successive periods of 1 (one) year each up to maximum age limit of 67 years in special circumstances after review of his/her performance. The appointment on contract basis in case of non retired candidate, shall be initially for one year which may be extended as per requirement for further period if his/her work is found satisfactory after review.
 - (b) The pay of retired person will be fixed on the basis of last pay drawn minus pension or on minimum basic pay plus Dearness Allowance (DA) admissible in the scale of the related post whichever is less.
- 4. While selecting the candidates for appointment, the Commission will also consider the satisfactory performance/experience of the candidates working in any of the Regulatory Commission, Central Government, State Government, Power Sector Utilities, Statutory body or reputed non Government Organisation and other PSUs.
