

The local criteria, as per GOI guidelines NHM, local residence within the village have been adopted for selection of the candidates on merit and from the adjoining/neighbor village / medical block where no eligible candidates was available from the particular village where the sub centre exist, with a view to ensure presence of health care service provider in the community.

**Terms and condition:-**

1. The hiring is purely on contractual basis up to **31.03.2017**, which will be renewable on 11 months basis, based on their performance.
2. The contractual hiring shall not confer any right on the appointee to claim extension or for regular selection at any time.
3. The selected candidates shall have to join this office by or before **25<sup>th</sup> of September 2016** along with all requisite testimonials for verification, failing which her selection shall automatically be treated as cancelled.
4. In case, if is found that any candidate was selected on the basis of false documents/ misrepresenting in the fact, his/her selection as such shall be deemed to be have cancelled and will be dealt under law of the land.
5. The selected candidates have also to execute an undertaking on affidavit as per format before joining.
6. The hiring shall be governed by other terms and conditions as are not specifically mentioned mentioned herein but are made applicable in case of such appointments at any time by the contracting authority.
