- 14. Canvassing in any form shall disqualify the candidates. No enquiry or correspondence will be entertained.
- 15. No TA/DA is admissible. Duration of each test can be 02 to 05 days or more. Candidates will make their own arrangement for lodging /boarding during the test. Depot will NOT make any arrangements.
- 16. Any dispute with regard to the recruitment will be subject to the Courts having jurisdiction in the state of Delhi.
- 17. Physical test will be the first test, followed by written, except where not applicable.

- 18. Written test will be conducted on OMR sheet. All candidates should acquaint themselves with this process.
- 19. No relaxation in test will be provided to Women candidates.
- 20. Candidates will wear shorts/trousers for physical tests & not run in underwear.
- 21. Requirement of scribe, for written test will be intimated 72 hours in advance to Unit Administration.
- 22.
