# I. QUALIFICATIONS PRESCRIBED:

- 1). Must be able to read and write Telugu and English.
- 2). Must possess a current valid Light Motor Vehicle Driving License with gear transport endorsement issued by competent Authority under the Motor Vehicle Act, 1988 with practical experience of driving Motor vehicles for a period not less than 3 years with endorsement to drive Motor Cycle and Car.

#### II. AGE LIMIT:

- 1.As on 01.07.2016, the candidate must have completed the age of 18 years and must have not completed the age of 34 years.
- 2. The age relaxation of maximum age limit in respect of S.Cs./S.Ts/B.Cs is 5 years. The age relaxation of maximum age limit in respect of Ex-service men will be as per the existing rules in which the notification for selection is made as prescribed in the A.P.General Subordinate Service Rules, 1995 r/w Rule 12(1)©(i) of A.P.
