- (d) Discuss the statement "Social Forestry is an aid to environmental conservation".
2. (a) Discuss the important agro-forestry systems/practices existing in different agro-climatic zones of the country with suitable examples. 20
- (b) Why the prescribed fire is recommended for effective forest resource management in many forests ? 20
- (c) Describe the basic objectives and salient features of National Forest Policy, 1988 and highlight the changes in current policy over 1952 policy. 20
3. (a) Mining leads to environmental problems. Discuss briefly the different environmental hazards that are created by mining along with corrective measures. 20
- (b) What are the multipurpose trees ? How different benefits are derived from such trees ? Write the characteristics and management practices of multipurpose trees suitable for agro-forestry. 20

- (c) What do you mean by the term market structure ? Explain briefly the components of market structure which determine the conduct and performance of the market. 20
4. (a) How National Park differs from a Sanctuary ? Why there is a need to establish more National Parks and Sanctuaries ? Give a brief description two National Parks and two Sanctuaries located in your state. 20
- (b) Write the present status of wildlife management in India with special reference to Odisha. 20
- (c) Describe the constitution, objectives and activities of National Wasteland Development Board. Also mention the different categories of wastelands occurring in India. 20
