2. AGE LIMIT:

- i. 35 years as on 01.01.2017, i.e., not born earlier than 01.01.1982.
- ii. Maximum of 5 years age relaxation for ST/SC (female and male) candidates, 02 years age relaxation for BC-I/BC-II candidates and 3 years age relaxation for female (UR/BC-I/BC-II) candidates.
- iii. Land losers/land displaced persons, due to land acquisition for the use of TVNL shall get relaxation of 5 years in maximum age limit.
 - For claiming relaxations in category of land losers/land displaced persons, the candidates shall have to produce certificate from concerned DC/SDO, to the following effect to avail the benefit:
 - a) That he/she is a land displaced person due to land acquisition for the use of TVNL.
- iv. The maximum age for regular employees/contract employees presently working in TVNL will be 50 years.

Experience: Preference will be given to candidates who have worked *in* equivalent positions in Government/Semi government organisations.

4. APPLICATION FEE:Non- refundable application fee is Rs. 1000/-(Rupees One Thousand only) only plus online bank transaction charges as applicable for all categories except ST/SC candidates of Jharkhand. The application fee for ST/SC

candidates of Jharkhand is Rs. 500/-(Rupees Five Hundred only) only plus online bank transaction charges as applicable.

- **5. EXAMINATION STRUCTURE:** Examination will be in two phase written examination and interview. Written examination may have multiple choice objective type questions. Candidates who qualify in written examination have to appear in the interview.
- **6. SERVICE AGREEMENT BOND:** All new recruits have to sign a service agreement bond for 03 years of Rs 3,00,000/-(Rupees three lakh)only at the time of joining.

7. PAY SCALE:

- ii. Personnel Officer, Accounts Officer, Safety Officer, Estate Officer: Pay Band Rs 9300-34800/-, Grade Pay: Rs 5500/-.
- iii. Assistant Personnel Officer: Pay Band Rs 9300-34800/-, Grade Pay: Rs 4600/-.
- iv. Assistant Operator: Pay Band Rs 5200-20200/-, Grade Pay: Rs 3000/-.

8. MODE OF SELECTION:

- i. The mode of selection will be written test followed by personal interview.
- ii. Written Test will comprise of objective type consisting of three parts-General aptitude, General knowledge and concerned discipline knowledge. There shall be negative marking for wrong answer.
- iii. Personal interview will be conducted for candidates those who qualify in the written test.
- iv. Merit list will be prepared on the basis of written test and personal interview.
- v. Work experience in relevant fields may be considered.

9. TEST CENTRES:

Written examination shall be conducted in Ranchi, Jharkhand.

10. HOW TO APPLY:

- ii. Candidates are required to login using their Unique Registration Number and password and upload their recent photograph (Max. 25 KB) and signature (Max. 15 KB) in .jpg or .jpeg formats only.
- iii. Non- refundable application fee is Rs. 1000/-(Rupees One Thousand only) only plus online bank transaction charges as applicable for all categories except ST/SC candidates of Jharkhand. The application fee for ST/SC candidates of Jharkhand is Rs. 500/-(Rupees Five Hundred only) only plus online bank transaction charges as applicable.
- iv. **METHOD OF APPLICATION FEE PAYMENT**: The candidates will have to relogin with credentials like Registration number and date of birth on the website
 - a. The Payment Gateway Charges will be borne by the candidates.

- b. Fees once paid will not be refundable under any circumstances. Candidates are therefore requested to verify their eligibility and other conditions are laid down before paying the application fees.
- c. All successfully enrolled candidates will be allowed to download the admit card from the website. Please note that the admit card will not be sent by post.
