Provisional Result of Written Examination of ALP & Tech against CEN-01/2014

DOCUMENT VERIFICATION (Phase-1) FOR CANDIDATES

On the basis of the performance in the Written Examination held on **29.06.2014** and Aptitude Test from **16.10.2014 to 20.10.2014** the following candidates have been provisionally found eligible to be called for Document Verification (D.V.) for the post of ALP. It may be noted that this result is provisional and subject to fulfilling of all eligibility conditions laid down in the Centralized Employment Notice No. 01/2014. Roll Numbers are arranged in ascending order (last six digits) and not in order of merit. While every care has been taken in publishing the result, this RRB reserves the right to rectify any inadvertent error or typographical mistake. This list comprises 50% more candidates than the number of actual vacancies. Therefore, all candidates attending DV may not be empanelled.

At the time of Document Verification, candidates should produce all original certificates and Documents issued by the competent authority for verification of date of birth, educational qualification, mark sheets, caste certificate and non-creamy layer certificate in case of OBC candidates having claimed any relaxation. In case certificates/mark-sheets original have not been received from respective Board/Council/University/Institute/SCVT/NCVT then provisional pass certificate and mark sheets issued by the respective Board/Council/University/Institute/SCVT/NCVT should be produced. SC/ST candidates must bring Caste/Tribe certificate as prescribed in Annexure-3 of the Centralized Employment Notice (CEN-01/2014) signed by Competent Authority. OBC candidates should bring up-to-date OBC certificate with Non-Creamy layer status as prescribed in Annexure-4 of the CEN. Please note that OBC candidates have to submit latest community certificate with non-creamy layer certification which is not more than one year old as on the date of document verification.

Minority community candidates having claimed examination fee exemption will have to submit affidavit in the prescribed format as per Annexure-8 of CEN No. 01/2014 on non-judicial stamp paper that he/she belongs to the minority community. If the affidavit is not produced during the document verification, the candidature will be liable to be rejected as per para-3.08 of CEN-01/2014.

Candidates having claimed examination fee exemption as Economically Backward candidate will have to submit family Income certificate of less than Rs. 50,000/- in the prescribed format as per Annexure-7 of CEN No.01/2014. If the income certificate is not produced during the DV, the candidature will be liable to be rejected as per para-3.09 of CEN-01/2014.

Candidates who are serving in any Central/State Government department including Railway or Public Sector Undertaking will have to submit No Objection Certificate (NOC) from the employer. If the NOC is not produced during DV the candidature will be liable to be rejected as per para - 5b(5.11) of CEN -01/2014.

Candidates belonging to PWD and Ex-SM categories will have to produce original documents in support of their claim as mentioned in CEN - 01/2014.

During DV, the candidates will have to produce their original certificates. The candidature of the candidates not producing their original certificates on the date of DV is liable to be forfeited as per Para 5(B). However OBC/SC/ST candidates, who fail to produce the original certificate according to CEN-1/2014 and feature in the UR merit list, will be accepted as UR candidates only.

Candidates must ensure that their name, date of birth, father's name and other particulars in their original certificates match with entries made in their application form. In case of variation in name/father's name/initial etc, gazette notification or any other legal document as applicable, stating that the name as filled in application and that appearing in the certificates refers to the same person, will have to be submitted at the time of document verification.

Candidates may please note that if they fail to produce the original certificates in support of date of birth/qualification/Caste/community in prescribed format/proof of Ex-Serviceman/proof of PWD/Minority Declaration/Income Certificate/NOC on the day of document verification, the candidature is liable to be forfeited without any further notice.

Candidates should bring two self-attested xerox copies of all original certificates and marksheets and other certificates and two recent colour passport size photographs for submission during DV.

Call letters are being dispatched by Speed Post to the candidates individually for appearing in the DV to be conducted in the RRB, Guwahati, Panbazar, Station Road, Guwahati- 781001. This RRB is not responsible for any postal delay or wrong delivery. However, if any candidate does not receive the call letter, he/she may report to RRB on date mentioned against each for duplicate call letter along with counter foil of the call letter of written examination. The candidates may be required to stay for more than one day and they must come prepared for it.

If a candidate is unable to attend Document Verification on the scheduled date and time, then he/she should attend Document Verification on the Block Date for Absentees. No further chance will be given to the candidates for Document Verification.

Candidates may get their documents verified at the earliest also without waiting for the specified dates by attending RRB, Guwahati's office on any working day during office hours before 15.11.2016 accompanied by all documents and call letter.

Note: (I) Call letter for Document Verification does not give any guarantee for employment in Railways. If it is found later at any stage that any candidate does not fulfill any of the conditions of eligibility, candidature will be cancelled and no appeal against such cancellation will be entertained. (II) All instructions given in the CEN-1/2014 must be complied.
