**ORDER:-**

**In view of the final merit list approved by the Hon'ble High Court in the category of Copyists under Notification No.7/2015 and direction to the District Judge to issue appointment orders subject to verification of antecedents; the undersigned is pleased to issue appointment orders to the following selected candidates after verification of their antecedents.**

**D.Venkata Narayana**, S/o.Chinna Veeraiah, D.No.4-1393, Podili Road, Pragathi Bazar, Darsi of Prakasam District is temporarily appointed as Copyist and posted as Copyist, Senior Civil Judge's Court, Darsi in the existing vacancy. On joining duty; the individual is deputed to work in Addl.Junior Civil Judge's Court, Markapur, until further Orders, to discharge the duties of a Junior Assistant.

**Note:-**

1. The selected candidates are informed that their appointments are purely on temporary basis and they are liable to be terminated at any time without assigning any reasons.
2. The selected candidates shall join the post within 30 days from the date of despatch of these proceedings. If any candidate does not join the post within the stipulated time of 30 days, these appointment proceedings shall be treated as automatically cancelled. Any request

from the candidates for extension of time to join duty will not be considered. They are directed to produce all original certificates of their Educational Qualifications, Proof of Date of Birth, Caste Certificate etc., at the time of joining duty.

3. At the time of joining duty; the above individuals shall produce Physical Fitness Certificate issued by a Medical Officer not below the rank of Civil Surgeon.
4. The individuals appointed on or after 1-9-2004 are only covered by the Contributory Pension Scheme and the pension scheme under A.P.Revised Pension Rules, 1980 will not be applicable to them as per G.O.Ms.No.653, 654 and 655 Finance (Pension-I) Department, Dated 22-9-2004.
5. The interse-Seniority of the newly selected candidates will be fixed as per the directions of the Hon'ble High Court 2<sup>nd</sup> read above and neither the seriatum mentioned in these proceedings nor the dates of joining of the individuals is a criterion to determine their seniority.
6. The orders are placed in the Official Website of Prakasam District and the downloaded copy is valid for relieving and reporting of the working employees.
7. The Officers concerned are instructed to relieve the transferred employees immediately **on or before 10-5-2016.**
