## **Recruitment for the post of Assistant General Manager in OSAM Board**

Applications are invited from eligible candidates in the prescribed form for appointment as Assistant General Managers on Contractual basis in Odisha State Agricultural Marketing Board to carry out functions of various technical / marketing cells of the Board.

### **I) ELIGIBILITY**

- (a) Educational Qualification: Two years full-time Post Graduate Diploma in Agri-Business Management / Full time MBA in Agri-Business / Agri Business Management from an Indian University / Govt. of India Institute.
- (b) Preference will be given to the candidates who have experience in the field of Agricultural Marketing.
- (c) Age: Candidate should not exceed 32 years as on the last date for receipt of application. Age relaxation shall be permitted to the extent of length of experience subject to a maximum age of 40 years in case of candidates possessing experience in the area of Agricultural Marketing. Age relaxation in case of reserved candidates shall be allowed as per extant provisions.
- (d) The candidate must have passed an examination equivalent to ME standard with Odia as a subject and be able to speak, read and write odia.

### **II) REMUNERATION:**

The selected candidates will be given a consolidated remuneration of Rs. 21,000 per month (Initial pay of PB-3, i.e. Rs. 15,600 plus Grade of Rs. 5,400). Besides, they will be entitled to House Rent Allowance, Medical Allowance and Travelling Allowance as applicable to Board employees.

### **JOB Requirements :**

- (a) Developing appropriate general and commodity specific strategies for efficient marketing of agricultural produce.
- (b) Formulating project proposals for development of agri markets / infrastructure.
- (c) Increasing farmers' access to Agricultural Commodity Markets for better price discovery mechanism / enhancing awareness among farmers regarding physical markets / e-marketing of Agril. Produce / quality and grade standard awareness amongst farmers.
- (d) Organizing FPOs / CIGs for marketing of Agril. Commodities.
- (e) Creating awareness about institutional support and credit link for Agricultural Marketing Operations.

- (f) Ensuring market led extension, promoting backward and forward linkages in marketing agricultural produce.
- (g) Undertaking field visit to RMCs across the State and identify geographical areas for efficient marketing of agricultural produce.
- (h) Preparing convergence plan for trading of agricultural produce.
- (i) Carrying out market / commodities specific analysis to bring improvement in marketing.
- (j) Strengthening contract farming / establishment of private markets / ensuring e-marketing for agricultural produce.
