The Ministry of Petroleum & Natural Gas (Government of India) has set up The Rajiv Gandhi Institute of Petroleum Technology (RGIPT) at Jais, Dist. Amethi, (Uttar Pradesh) through an Act of Parliament ("Rajiv Gandhi Institute of Petroleum Technology Act - 2007"). RGIPT has been accorded the eminence of being an "Institute of National Importance" along the lines of the Indian Institutes of Technology (IIT). RGIPT is co-promoted as an energy domain-specific institute by six leading Oil PSUs in association with the Oil Industry Development Board (OIDB). The prime objective of the Institute is to provide world class education, training, and research to roll out efficient human resources to meet the growing requirements of the Petroleum & Energy sector. RGIPT's academic campus with residential facilities is set up at Jais (Amethi, UP).

Applications on the Prescribed Form are invited from the eligible candidates for appointment to the posts at RGIPT. The applications should reach the Institute or on before March 10, 2017.

Post No. 1 - Permanent. Age of Superannuation is 62 years.

Post No. 2 & 3 - On contract for a period of 5 years and thereafter may be regularized/renewed on similar terms/terminated. Age of Superannuation is 60 years.

ELIGIBILITY CRITERIA

Post No.1 : Finance Officer

Upper age limit: 56 years as on last date fixed for submission of applications.

a) Job Responsibility:

Subject to the overall control of the Act and the Statutes of RGIPT, the Finance Officer (FO) shall inter-alia exercise general supervision over the funds of RGIPT (including its other academic Centers), perform such other financial functions as may be assigned to him by the Director, Finance Committee and/or Board of Governors or as may be specified by the Ordinances. He will develop investment strategies and supervise all financial statutory compliances. The FO will administer payroll, cash management operations of the Institute and will be responsible for the preparation of the Annual Accounts of the Institute including the Balance Sheet and will co-ordinate with all External and Internal Audits. He will carry out financial evaluations of proposals and will advise the Director in all financial matters of the Institute. The FO will also be responsible to provide all the financial information as sought by the Ministry.

b) Essential Qualification and Experience:

Master's Degree with at least 55% marks in aggregate or its equivalent grade of 'B' in the UGC seven point scale in any discipline.

Experience: (i) 15 years of experience in financial administration in centrally funded research establishments or institutes of higher education of which 8 years shall be as Deputy Registrar or an equivalent post in the Grade Pay of Rs.7600/- and above

OR

At least 15 years of experience as Assistant Professor in the AGP of Rs.7000/- and above, or 8 years of service as Associate/Assistant Professor in the AGP of Rs.8000/- or above, in financial administration in similar organizations/institutions mentioned above.

OR

Holding analogous regular position, with comparable experience of leading finance and accounts department in reputed Central Govt. Organization/Central PSU/or other centrally funded institutions of higher education.

Desirable Experience:

- i) Independent fiscal administration (In-charge) of any centrally funded institution for 5 years or above, supervising fund management, investment, budgeting, preparing the Annual Accounts and coordinating both Government Audits and Internal Audit.
- ii) Implementation of finance processes and policies in any centrally funded institution.
- iii) Accounting of capital projects > Rs.200 Cr.
- iv) Competence in all forms of Communication with computer proficiency.

Post No. 2 : Assistant Registrar (Audit)

Upper age limit: Below 45 years, as on last date fixed for submission of applications

a) Job Responsibility:

Will assist the institute accomplish its objectives by evaluating and objectively reviewing the efficacy of existing controls, statutory compliance and governance process. Will act as a Management tool to provide independent, objective assurance and make recommendations how to improve the internal controls in all areas of operation of the institute.

Essential Qualification and Experience:

Master's Degree with at least 55% marks in aggregate or its equivalent grade of 'B' in the UGC seven point scale in any discipline.

Experience: Minimum 8 years experience in one or more of the following areas: Accounting, Auditing, working knowledge of Financial and Administrative matters including Establishment, Academic matters, Estate, Materials Management & Import procedures of which at least 3 years in a Supervisory/Superintendent capacity in the PB-2 (Rs.9300-34800) with a Grade Pay of Rs. 4600/-

OR

Holding analogous regular position, with comparable experience in Central Govt. Organization/Central PSU/or other centrally funded institutions of higher education.

Desirable Experience:

- a) Candidates should have leadership qualities and working experience in Auditing, Financial and Administrative procedures any centrally funded institution.
- b) Candidate should have effective communication skills and computer proficiency.

Post No.3 : Assistant Registrar (Accounts)

Upper age limit: Below 45 years, as on last date fixed for submission of applications

a) Job Responsibility:

Shall be inter-alia responsible for processing payments and monitoring income & expenditure, ensure that all the organization's finances are precise and up to date. Will provide reliable and pertinent information for organizing and allocating funds, Bank Reconciliation, ensure all statutory compliance, compilation of Annual Accounts and will control capital and revenue expenditures of the institute improving transparency and accountability.

Essential Qualification and Experience:

Master's Degree with at least 55% marks in aggregate or its equivalent grade of 'B' in the UGC seven point scale in any discipline.

Experience: Minimum 8 years experience in areas of Finance and Accounting, working knowledge in Govt. financial procedures, materials management & Import processes of which at least 3 years in a Supervisory/Superintendent capacity in the PB-2 (Rs.9300-34800) with a Grade Pay of Rs. 4600/-. Applicant should be proficient in **Tally** accounting software.

OR

Holding analogous regular position, with comparable experience in Central Govt. Organization/Central PSU/or other centrally funded institutions of higher education.
