Temporary Engagement of Guest Faculty

Candidates are invited for a walk-in-interview on date and time given below for engagement as Guest faculty in the subjects of **Applied Geography, Chemistry, Commerce, History, Odia, Physics, Psychology, Sociology, Computer Science, Environmental Science and English**. The engagement is purely temporary for one Semester with a fixed remuneration (as per Government of Odisha norms) per teaching hour. The eligibility criteria is same as for lecturer in the mentioned subjects as led down in **para 4 of UGC regulation 2010 published in Gazette of India**. However, relaxation will be given if the required number of eligible candidates in accordance with the said regulation is not available.

1. The candidates are required to come to the interview along with filled in application (format enclosed) and a set of self attested copies of their certificates & mark-sheets of all examinations passed and a passport size photograph pasted on the front page. **No application by post or by hand is required** to be submitted before the mentioned date of interview.
2. The engagement is purely temporary for one Semester or till appointment of a regular faculty whichever is earlier. There should be no extension of engagement beyond one Semester. Canvassing in any form will lead to the disqualification of the candidate.
