Essential Qualification & Experience – Matriculation/SSLC and ITI in the relevant trade with one year relevant experience. If the ITI course duration is less than 2 years, 2 years relevant experience after obtaining the certificate is essential.

For OBC Candidates : OBC Certificate should be produced as per the format issued by DOPT vide No. – 36036/2/2013-Estt.(Res.) dated 30.05.2014. Revised format is annexed hereto.

Job requirement - Operation, repair, fabrication, handling, packing, installation and maintenance of exhibits / equipment / instruments /installation. The Candidate will also be required to travel widely with Mobile Science Exhibition unit on payment of TA/DA as per rules.

Age limit - 35 years as on 01st Feb, 2018. Upper age limit is relaxable for candidates who belong to SC/ST/OBC/PWD/Ex-Serviceman as per Government of India rules.
