Adherence to truth and non-violence, participation in productive work with a sense of dignity to labour, respect for all religions, creed and communities, social and economic equity, and above all priority for rural reconstruction are emphasized in all curricula. Education is largely imparted in mother-tongue i.e., Gujarati. However, in exceptional cases learning and guiding in Hindi and English with prior permission. But it is expected that teachers pick up Gujarati within a short time.

**Qualifications and Experience:**

- An eminent scholar with Ph.D. qualification(s) in the relevant subject and published work of high quality, actively engaged in research with evidence of published work with a minimum of 10 publications as books and/or research/policy papers.
- A minimum of ten years of teaching experience in university/college, and/or experience in research at the University/National level institutions/industries, including experience of guiding candidates for research at doctoral level.
- Contribution to educational innovation, design of new curricula and courses, and technology - mediated teaching learning process.
- API Score based on PBAS be sent along with the application as per UGC Regulations 2016 and amendments from time to time. Those not having minimum API Score will not qualify. Consolidated API score requirement of 400 points from categories II and III of APIs (cumulative).

**Qualifications and Experience:**

- Good academic record (with 50% in undergraduate courses).
- A Master's degree in relevant subject with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed).
- Ph.D. Degree in the relevant subject.
- Minimum eight years' experience in teaching and/or research in an academic / research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/Industry excluding the period of Ph.D. research with evidence of published work and a minimum of 5 (Five) publications as books and/or research/policy papers.
- Contribution to educational innovation, design of new curricula and courses, and technology - mediated teaching learning process with evidence of having guided doctoral candidates and research students.
- API Score based on PBAS be sent along with the application as per UGC Regulations 2016 and amendments from time to time. Those not having minimum API Score will not qualify. Consolidated API score requirement of 300 points from categories II and III of APIs (cumulative).

**Qualifications and Experience:**

- i. Good academic record (with 50% in undergraduate courses) with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed), from at the Master's degree level in relevant subject from an Indian University, or an equivalent degree from an accredited foreign University.
- ii. Besides fulfilling the above qualifications, the candidate should have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like NET/SLET.
- iii. Notwithstanding anything contained in sub-clauses (i) and (ii) to this Clause above, candidates, who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions.  
"Provided further, the award of degrees to candidates registered for the M.Phil/Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / By laws / Regulations of the Institutions awarding the degrees and the Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/ Institutions subject to the fulfilment of the following conditions:-


- (a) Ph. D. degree of the candidate awarded in regular mode only;
- (b) Evaluation of the Ph.D. thesis by at least two external examiners;
- (c) Open Ph.D. viva-voce of the candidate had been conducted;
- (d) Candidate has published two research papers from his/her Ph.D. work out of which at least one must be in a refereed journal;
- (e) The candidate has made at least two presentations in conferences/seminars, based on his/her Ph.D. work.

(a) to (e) as above are to be certified by the Vice-Chancellor/Pro-Vice-Chancellor/ Dean (Academic Affairs)/Dean (University Instruction).”

**General Conditions:**

1. Candidate employed in Govt./Quasi Govt./Public Sector Undertaking should forward their application through proper channel.
2. Separate applications are to be submitted for each posts.
3. Medium of instruction at all levels is generally in Gujarati; hence knowledge of Gujarati/Hindi is essential.
4. The University reserves the right not to fill up any of the vacancies advertised and may increase or decrease the actual number of posts in a discipline depending on the circumstances.
5. The University also reserves the right to invite applications, interview/seminar and appoint qualified and deserving candidates.
6. All delayed, incomplete, without API/PBAS documents and the application that are not in the prescribed form will be rejected. No intimation in this regard will be sent to candidates.
7. API Score based on PBAS be sent as per UGC regulation applicable.
