1. Applications shall be received through ONLINE mode only on visiting the website "[www.bseodisha.ac.in](http://www.bseodisha.ac.in)".
2. ONLINE link will be available (24 x 7) from 12/11/2018, 8 am to 27/11/2018, 11.45 pm.
3. The payment of fee shall be done through SBI Collect either in online or offline mode latest by 11.45 pm of 27/11/2018. However filling up of forms through online can be carried out till 28/11/2018 midnight.
4. The step by step instructions for online registration, applicability & eligibility of candidates, syllabus & its structure, instructions for physical handicapped candidates & format for continuing certificate are available in the website "[www.bseodisha.ac.in](http://www.bseodisha.ac.in)".
5. Candidates can appear Paper-I or Paper-II or both the papers as per their eligibility. The candidates appearing both Paper-I & II shall have to fill up application form separately.
6. Under no circumstances the last date for submission of application forms shall be extended.
