- (1). MBBS with Post Graduate Degree/ DNB/ Diploma or equivalent as per residency scheme in concerned specialty from a recognized University/ Institution.
- (2). In the condition, if candidates having P.G. degree/DNB/Diploma are not available, those without P.G. qualification but having 02 years experience in concerned speciality may be considered.
- B. Age: Below 40 years, On Date of Interview, as per order No.F.DHF&W/Q015/57/2016-HR-Medical-secy(H&FW)E.6146/2361-67 dated 04/12/2017.
- C. Pay: Basic of RS. 67700/- in pay Matrix 11 of 7th CPC with other allowances as admissible per month.
- <u>D.</u> The candidate must have completed internship.
- E. Must be registered with Delhi Medical Council.
- <u>F.</u> Appointment will be initially for a period of 44 days or till the recruitment of Senior Resident on Regular Basis, whichever is earlier.
