(i) For Gen & OBC candidates: 18-28 years as on 01 Jan 2019. Candidates should have not been born earlier than 01 Jan 1991 and later than 01 Jan 2001.

(ii) For SC & ST candidates: 18-33 years as on 01 Jan 2019. Candidates should have not been born earlier than 01 Jan 1986 and later than 01 Jan 2001.

- (b) Only Matriculation Certificate or Higher Secondary School Certificate will be accepted as a proof for establishing age of the candidates.
- (c) The candidates must fulfil all eligibility conditions and should be in possession of all sports and education certificates at the time of joining.
- (d) All educational certificates other than Central Board/ State Boards should be accompanied with Government notifications declaring the equivalence of such qualification for service under Central Government.
- (e) The candidates seeking relaxation under SC / ST / OBC category should submit the certificate as per prescribe format. In the event of non-enclosure of the certificate, the candidate will be considered under General (UR) category. Any applicant who does not fulfil the prescribed eligibility conditions, his/her application/candidature will be summarily rejected.

#### 9. Order of Preference.

(a) First preference may be given to those candidates who have represented the country in an International Competition with the clearance of the Department of Youth Affairs and Sports.

(b) Next preference may be given to those who have represented a State / UT in the Senior or Junior level national Championships organized by the National Sports Federations recognized by Department of Youth Affairs & Sports or National Games organized by Indian Olympics Association and have won medals or positions upto 3rd place.Between the candidates participating in Senior and Junior National Championships / Games, the candidates having participated and won medal in Senior National Championship should be given preference.

(c) Next preference may be given to those, who have represented a University in an Inter University competition conducted by Association of Indian Universities / Inter University Sports Board and have won medals or positions upto 3<sup>rd</sup> place in finals.

(f) Next preference may be given to those, who have been awarded National Award in physical efficiency under National Physical Efficiency Drive.

(g) Irrespective of levels of participation and medal won, a Field Trial in respective sport will be carried out before final selection.

#### 10. Selection Process.

(ii) The candidates must not have knock-knee, flat foot, varicose veins, squint in eyes and they should possess high colour vision. The candidates will be tested for colour vision by ISIHARA's test as well as Edrioh Green Lantern test.

(iii) Must be in good mental and bodily healthy and free from any physical defect likely to interfere with the efficient performance of their duties.

(iv) Criteria to Determine Permissibility of Tatoo. The practice to engraving/ tattooing in India is prevalent since time immemorial, but has been limited to depict the name or a religious figure, invariably on inner aspect of forearm and usually on left side. On the other hand the present young generation is considerably under the influence of western culture and thus the number of potential recruits bearing skin art had grown enormously over the year, which is not only distasteful but distract from good order and discipline in the force.

(aa) Content. Being a secular country, the religious sentiments of our countrymen are to be respected and thus tattoos depicting religious symbol or figure and the name as followed in Indian army, are to be permitted.

(ab) Location. Tatoos marked on traditional sites of the body like inner aspect of forearm, but only LEFT forearm being non saluting limb or dorsum of the hands are to be allowed.

(ac) Size. Size must be less than ¼ of the particular part (Elbow or Hand) of the body.

Note:- The candidates will be examined as per the Revised Medical Guidelines May 2015 issued by ADG (Medical) CAPF, NSG & AR.

- Appeal against Findings of Detailed Medical Examination. If a candidate (j) is declared UNFIT in the Detailed Medical Examination (DME), the grounds for rejection will be communicated to him/ her by the Presiding Officer. If the rejected candidate is not satisfied with the findings of the Medical Officer, he/ she will obtain Form 1, 2 & 3 from the Presiding Officer of Recruitment Board concerned to prefer an appeal for Review Medical Examination (RME) within 15 days from the date of issue of information in which the findings of the Medical Officers is communicated to him/her. The appeal should necessarily contain the following (a) Review Medical Examination Fee (Rs 25) non-refundable through a Postal Order in favour of concerned authority to be intimated by the Presiding Officer of Recruitment Board and (b) Appeal Form 1, 2 & 3 issued by the DME Board declaring the candidate as Unfit. Fitness certificate other than Form 3 (provided by the Presiding Officer of Recruitment Board to the candidate) will not be considered for Review Medical Examination (RME) and appeal will be rejected straightway. The fitness certificate on Form 3 is essential to consider his/ her case for Review Medical Examination and not for any other purpose.
- Those candidates whose appeals are found in order will be intimated by Email/ (k) SMS through Email ID and Mobile Phone numbers provided by him/ her in Online Application Form to appear for Review Medical Examination (RME) and their list will also be uploaded in the Assam Rifles website www.assamrifles. gov.in. No intimation will be sent by post.
- (I) The decision of the Review Medical Examination Board will be final and second appeal will not be entertained as per instructions of the Government and no reply of the correspondence / second appeal will be given/ entertained.

Note: - Being declared FIT in Medical Examination will not guarantee any legal claim or right to any candidate for final appointment in Government service.

11. Final Selection. Final selection will be done on the basis of level of participation/ achievements and performance in Field Trials. Please note that merely qualifying in all tests does not guarantee the Final Selection into the Assam Rifles. The Final Selection will only be made on the basis of position of the candidates in Merit List in accordance with the availability of vacancies in the respective sports discipline.

- Conduct of Field Trial. The Field Trial in all disciplines will be conducted by a 12. Merit List and Issue of Provisional Appointment Letter. The candidates who qualify in all respects i.e Level of participation/ achievements, Physical Standard Test (PST), Medical Examination Test and performance in Field Trial will be placed in Merit List depending upon discipline wise vacancies allocated. Provisional appointment letters wil be issued to the Meritorious candidates in accordance to the vacancies available against respective sports discipline.

Trial. Merit list will be prepared based on performance in Field Trail. In case of 13 Rejection of Applications. In case the information furnished by the candidates a tie, preference will be given as per paragraph 9.

(iii) Pregnancy at the time of PST and Field Trial will be considered a disgualification and pregnant female candidates shall be rejected at this stage. An undertaking of not being pregnant will be taken from all female candidates before PST and Field Trial.

(iv) Rejection slip will be issued to the candidates who are not gualified in PST and Field Trial.

- Appeal against Physical Standard Test (PST). Candidates declared (h) disgualified in Physical Standard Test can prefer an appeal to the Appellate Authority for re-measurement of Height and Chest only. The appeals of the candidates shall be disposed off on the same day by the Appellate Authority.
- Detailed Medical Examination (DME). The candidates who qualify in Field (i) Trial in respective sports discipline will undergo Detailed Medical Examination (DME). The Medical Standards are as under:-
