## **CORRIGENDUM**

In partial modification of Advt. No. 5(ii)/2018 for the posts of Medical Officer HCMS-I Class-I in Labour Department, Haryana published on 29.12.2018 in various Newspapers (The Indian Express (Delhi, Chandigarh), The Tribune (Delhi, Chandigarh), Dainik Bhaskar (Chandigarh, Haryana), Hari Bhoomi (Chandigarh, Haryana), Dainik Jagran (Chandigarh, Haryana) vide which the applications were invited for 41 posts of Medical Officer in Labour Department, it is hereby announced that on receipt of requisition for additional 40 posts of Medical Officer, the number of posts have been increased from 41 to 81. The last date for submission of online application form of all these posts is hereby extended upto 11.3.19 (closing date), date for deposit of application fee in any branch of State Bank of India upto 2.3.19 (2:00 PM). The qualification and age will be calculated as on 11.3.19 (Closing date) and all the candidates who had applied earlier in response to the Advt. No. 5(ii)/2018 need not apply again as their previous applications will be considered if they are otherwise found eligible. It is clarified that the age of these candidates who have applied earlier will also be calculated as on 11.3.19 (Closing date) for the purposes of assessing their eligibility. However such candidates can update their qualification, category & experience etc. The eligibility with respect to qualification etc. will be considered as on the last date of submission of application forms for these posts i.e. 11.3.19 (Closing date).

Note:1 - Candidates are directed to send the hard copies of their online application form alongwith self attested copies of their Certificates/Supporting documents as claim in the online application form to the Commission's Office addressed to The Secretary, HPSC, Bay No. 1-10, Block-B, Sector-4, Panchkula, Haryana through registered post or by personal delivery at reception on or before closing date i.e. 12.3.19 failing which their candidature will not be considered for this recruitment).

Note :2 – The Eligibility of eligible sports person (ESP) will be determined as per Govt. notification no. 4/40/2017-4SYA dated 25.05.2018 and notification even No. dated 15.11.2018 which are available on our website.
