Telangana State Level Police Recruitment Board has been conducting Physical Measurement Tests and Physical Efficiency Tests (PMT / PET) since 11th February 2019. Amberpet, Yousufguda and Kondapur in Hyderabad, Warangal, Karimnagar, Khammam, Mahbubnagar, Nalgonda, Adilabad, Nizamabad and Sangareddy have been the 11 Venues for the PMT / PET Process which will be concluding shortly.

Performance Sheets – 99.9% Already Issued

Candidates have been performing very well during the last 4-5 weeks and as on date, **99.9% Performance Sheets of the 2,17,361 Candidates pertaining to the last 30 working days have already been hosted in the login area of Candidates on the TSLPRB Website www.tslprb.in**. Nearly 250 Performance Sheets are held-up temporarily for technical or data-inconsistency related reasons and these pending (nearly 0.1%) Performance Sheets are being hosted gradually after due resolution of technical or data related issues and all of them will be hosted well before the Hall Tickets are issued for Final Written Examinations.

Committee to Conduct PMT / PET of Backlog Cases on 28th and 29th March

During the conduct of the PMT / PET there have been certain cases wherein Candidates *in the last minute*, (a) informed that they could not produce caste certificates issued by authorities of Telangana State Government, (b) requested for change of Ex-Servicemen status from Yes-to-No or No-to-Yes, (c) requested for change of ABO-ST Status from No-to-Yes and Yes-to-No, (d) requested for change of gender from Male-to-Female and Female-to-Male owing to their own mistakes in filling the Online Application, (e) requested for change of caste from SC / ST / BC to OC and (f) very few Candidates with *miscellaneous issues (individual text / email messages are being sent to these Candidates)* including those of invalid / inconsistent data or Court related matters. **A Committee of Chief Superintendents and Officers with pertinent expertise will be available at the SAR CPL Amberpet, Hyderabad from 6 am onwards on the 2 days of 28th and 29th March to resolve all such and similar backlog issues of all the 11 Venues of PMT / PET, before the PMT / PET – Final Reports of all the individual participants (which will be the basis of issuing Hall Tickets for the ensuing Final Written Examinations), are published by the Board.**

Opportunity to Candidates – to Edit Application Data

The Board is aware that certain erroneous entries / uploads have been made by a few Candidates while filling their Online Applications. In this regard, Candidates are advised not to approach the Board at this stage through requests either in writing or by mails / messages. **All those parameters that have a bearing on the evaluation / qualification of each individual Candidate, till the conclusion of the Final Written Examinations (FWE), have already been taken care of by TSLPRB.** Also, Candidates are likely to be given a chance to modify / correct the erroneous entries / uploads, if any, made by them – at an appropriate time by ‘Edit Option’ or otherwise. Therefore, Candidates are advised to not worry about these errors / mistakes as long as they do not have anything to do with their evaluation in the PMT / PET or FWE.

Beware of Touts and Fraudsters

Candidates are once again cautioned against those unscrupulous elements / touts that may try to dupe innocent people / unemployed youth with false promises of providing them jobs. At times, they promise jobs by using forged / fake documents and videos, e-mails and website-posts and other forms of communication, to authenticate their claims. Do not believe them or give any money to such people – just inform the Police or TSLPRB authorities immediately and be assured that your identity will be kept secret. The Board has been taking consistent measures to initiate criminal action on any such fraudsters as well as those reprobate Candidates who collude with them. Please note that, the process of recruitment is carried out absolutely fairly and transparently, through institutions which have reputation of carrying out such exams with the highest integrity. In this regard, the Candidates are alerted to pay no heed to any false, sensational or unsubstantiated rumours and they are advised **to rely only on the information either provided on the TSLPRB website: www.tslprb.in in the Latest News section of the Home Page or in the Press Notes.** If any further clarification is required, Candidates are advised to contact us on 93937 11110 or 93910 05006.
