# Driving Test on 2<sup>nd</sup>-10<sup>th</sup> May and Mechanic Trade Test on 9<sup>th</sup>-10<sup>th</sup> May 2019

As per Para 17 B (iii) of the Recruitment Notification in Rc No. 90 / Rect / Admn-1 / 2018 dated 31st May 2018, Candidates of SCT Police Constable (Mechanics) (Men) in PTO who qualified in the Physical Efficiency Test will be required to appear and qualify in a **Trade Test** as per the designated procedure. Similarly, as per Para 17 B (iv) of the said Recruitment Notification, Candidates of SCT Police Constable (Drivers) (Men) in PTO who qualified in the Physical Efficiency Test will be required to appear and qualify in a **Driving Test** as per the designated procedure. **The Driving Test / Mechanic Trade Test will be conducted at SAR CPL Amberpet, Hyderabad from 2<sup>nd</sup> to 10<sup>th</sup> May 2019**.

## Admit Cards Downloadable from 27<sup>th</sup> to 30<sup>th</sup> April 2019

All the Candidates who have qualified for Driving Test / Mechanic Trade Test are informed that their individual <u>Admit Cards can be downloaded from 8 a m on 27<sup>th</sup> April</u> <u>onwards till 12 midnight on 30<sup>th</sup> April 2019</u> by logging into their respective user accounts on the TSLPRB website: *www.tslprb.in* by entering their credentials. ## **Instructions to Candidates**

After downloading the Admit Card, Candidates <u>shall take a printout of the same</u>, preferably on <u>A4 size paper</u>. Admit Card has 2 parts, <u>the top portion</u> having details of Date and Venue, Candidate Particulars and details of List of Documents to be submitted at the Venue of Driving Test / Mechanic Trade Test <u>must be</u> <u>preserved till the final conclusion of the process of Recruitment</u>. The <u>bottom portion of the Admit Card /</u> <u>is a Check Slip which will be taken away</u> by the Representative Officer of the TSLPRB (<u>along with Self</u> <u>Attested Photocopies of the Relevant Certificates submitted by each Candidate</u>) at the time of allowing the Candidate to register for Driving Test / Mechanic Trade Test on the date of the Test.

Candidates *shall* bring along the following documents (<u>whichever are relevant</u>) to the Venue of Driving Test / Mechanic Trade Test without fail, as *these are essentially required for their registration for the Test* –

- 1. Print-Out of PMT / PET Final Report duly Signed by the Candidate
- 2. Original Driving Licence of Light Motor Vehicle (Transport) or Heavy Motor Vehicle Licence (*For* <u>Driver Posts only</u>)
- 3. Self-Attested Photocopy of Driving Licence (For Driver Posts only)
- 4. Self-Attested Photocopy of ITI Certificate in Wiremen OR Mechanic Motor Vehicle OR Mechanic Diesel OR Fitter (as on 1<sup>st</sup> July, 2018) OR Higher Qualification than the prescribed one (as on 1<sup>st</sup> July, 2018) (*For Mechanic Posts only*)

<u>Candidates are advised to visit their Venue of Driving Test / Mechanic Trade Test one day prior</u> to the actual Date of Test and make sure about the Venue. No traveling expenses will be paid for the journey, if any performed, to take the Test.

Candidates are advised to <u>be punctual in reporting at the Venue at the Time and on the Date given</u> <u>in their Admit Card</u>. If any Candidate fails to do so, it will be presumed that he is not interested in participating in further process of recruitment and his candidature will automatically lapse.

Candidates are advised <u>not to bring any unnecessary personal belongings to the Venue</u> of Driving Test / Mechanic Trade Test as such material may become a hindrance to their effective participation in the Driving Test / Mechanic Trade Test. Candidates are advised not to come for the examination carrying handbags / *jholas* / pouches etc. *No Cloak Room* / *Storage Facility to safeguard any valuables or belongings of the Candidates is available at the Examination Centre.* 

There will be verification of identity of each Candidate based on the Biometric Data available with TSLPRB before permitting them to undergo the Driving Test / Mechanic Trade Test. Therefore, *Candidates are advised not to have mehendi, temporary tattoos or any obstructive material-covers on their fingers which may hamper the verification of Biometrics.* 

Adoption of any kind of unfair means or any act of impersonation during the Driving Test / Mechanic Trade Test will render the Candidate liable for invalidation of his candidature as well as appropriate criminal action.
