Completion of PMT / PET Process

Physical Measurement Tests and Physical Efficiency Tests (PMT / PET) in the ongoing process of Recruitment have been conducted from 11th February 2019 onwards at 11 Venues: **Amberpet (32 Days), Yousufguda (31 Days), Kondapur (31 Days), Warangal (31 Days), Khammam (29 Days), Karimnagar (26 Days), Nalgonda (26 Days), Mahbubnagar (22 Days), Adilabad (15 Days), Nizamabad (13 Days) and Sangareddy (11 Days)** and the PMT / PET Process finally concluded more than 10 days ago at the end of the 2-Day Session held by a Committee of Chief Superintendents and Experts at the SAR CPL Amberpet, Hyderabad on 28th and 29th March to resolve any Court / Data-Discrepancy related and all such / similar backlog issues of all the 11 Venues of PMT / PET. PMT / PET Final Reports are available in the individual login areas of the Candidates on the TSLPRB Website.

Qualification of Candidates in Different Venues

99.9% of the Candidates who attended the PMT / PET were Biometrically verified with their records that had been created during Preliminary Written Test and only on such authentication they were administered the PMT / PET. In the case of rest 0.1% (less than 250 Candidates), other reliable alternative methods of authentication have been employed. The 3 Venues of SAR CPL Amberpet, 1st TSSP Battalion Yousufguda and 8th TSSP Battalion Kondapur along with the Warangal Venue functioned for more than 30 working days and accounted for almost 50% of the total PMT / PET exercise. The Venues of Khammam, Karimnagar, Nalgonda and Mahbubnagar functioned for 20-30 working days and these 4 Venues administered PMT / PET to nearly 40% of the total Candidates. Adilabad, Nizamabad and Sangareddy catering to lesser demands, functioned for 10-15 working days and have taken care of the remaining 12-15% of the Candidates. As can be seen from the Table above, 1,17,660 Candidates, more than 52% of the participating 2,24,741 have qualified and have become eligible to take FWE/s. In the present PMT / PET, for the first time in the history of Police Recruitment in our State, Men and Women Candidates have been segregated and were allotted different days and as a result, substantial time-economization could be achieved due to day-wise specialization and focus on particular set of events.

Qualified Candidatures for Various Notified Post Categories

On the conclusion of the PMT / PET, 54,198 Candidates (44,226 Men and 9,972 Women) remain in the competition for 1,217 Notified Posts of SI Civil and/or equivalent as can be seen from the Table below and similarly, 1,05,061 (80,527 Men and 24,534) became eligible to compete for the 16,925 Notified Posts of PC Civil and/or equivalent.

At present, 1,17,660 Candidates (89,634 Men and 28,026 Women) having 1,71,253 Candidatures (1,35,283 Candidatures of the 89,634 Men and 35,970 Candidatures of the 28,026 Women) are present in the competition.

Exceedingly Superior Performance of Candidates in PWT and PMT / PET - 2018

From the Table shown below, it is very clear that Candidates performed overwhelmingly better in this Recruitment process when compared to the earlier Recruitment that was conducted during 2015-2016. At the stage of Preliminary Written Test, the percentage of qualification for the Posts of SI Civil and/or equivalent has increased from 50.80 in 2015-16 to 62.15 in the present Recruitment – a tremendous rise of 11.35 percent points. Similarly, the percentage of qualification for the Posts of PC Civil and/or equivalent has increased from 39.06 in 2015-16 to 50.90 in the present Recruitment – a steep improvement of 11.84 percent points. In the case of Technical SI / ASI Posts, the percentage of qualification at the stage of Preliminary Written Test has increased from 17.36 in 2015-16 to 47.30 in the present Recruitment – a tremendous growth of 29.95 percent points.

As far as PMT / PET (which is the second stage of the Recruitment Process) is concerned, Candidates of the present Recruitment Process have consistently shown better performance: 48.99% of the eligible Candidates for the Posts of SI Civil and / or equivalent qualifying this time as compared to only 37.03% in the last Recruitment (an increase of 11.96 percent points); 39.27% of the eligible Candidates for the Posts of SI / ASI Technical qualifying this time as compared to only 29.14% in the last Recruitment (an increase of 10.13 percent points); 45.91% of the eligible Candidates for the Posts of PC Civil and / or equivalent qualifying this time as compared to only 42.23% in the last Recruitment (an increase of 3.67 percent points) and 29.25% of the eligible Candidates for the Posts of PC Technical qualifying this time as compared to only 42.05% in the last Recruitment (an increase of 3.67 percent points) and 29.25% of the eligible Candidates for the Posts of PC Technical qualifying this time as compared to only 20.05% in the last Recruitment (an increase of 9.2 percent points). Adoption of technology has inferably benefitted the Candidates, on the whole.

Owing to the better performance shown by the Candidates, of all the Registered Candidates who applied for various Posts in this Recruitment, at the conclusion of the PMT – PET Process (which is the second and penultimate stage of the Recruitment Process) nearly 22% Candidates of PC and/or equivalent Posts remain in fray (as against only 15% in the previous Recruitment); 29% Candidates of SI and/or equivalent Posts remain in fray (as against only 18% in the previous Recruitment); 14% Candidates of SI / ASI Technical remain in fray (as against only 4% in the previous Recruitment) and 29% Candidates of PC Technical remain in fray (as against only 20% in the previous Recruitment).

To sum up, more than <u>1 lakh and 5 thousand Candidates will be taking the Final</u> <u>Written Examination for the Post of PC Civil and/or equivalent this time which is nearly 25</u> <u>thousand more than the Candidates of the previous Recruitment which was slightly more than</u> <u>81 thousand</u>. Similarly, more than <u>54 thousand Candidates will be taking the FWE for the Post</u> <u>of SI Civil and/or equivalent now which is approximately 21 thousand more than the Candidates</u> <u>of the previous Recruitment numbering around 33 thousand</u>. Nearly <u>5 times the Candidates of</u> <u>FWE of SI / ASI Technical which was approximately 600 – that is more than 3 thousand</u> <u>Candidates will appear this time</u> and <u>nearly 9 thousand PC Technical Candidates will be taking</u> <u>FWE in the present Recruitment which is much higher than the nearly 5 thousand Candidates</u> <u>who appeared in FWE in the previous Recruitment</u>.
