2. The candidates of those categories against which no post was advertised, shall be considered against the vacancies of General category if they fulfill all the conditions of eligibility as meant for General category candidates except fees.
3. Candidates are directed that they may download the admit card and take black & white print of the same on A-4 size paper so that their photos & other particulars can easily be seen / verified. Candidates having small size Admit Cards with illegible photos / signatures will not be allowed to enter in the Examination centre.
4. The entry of the candidates in the Examination Centre will be allowed from 08:50 A.M. to 09:50 A.M. No Candidate will be allowed to enter in the Examination Centre/venue after 09:50 A.M.
