#### **Conclusion of Certificate Verification**

Verification of the Certificates of all those Candidates who qualified in various Final Written Examinations (FWEs) in the ongoing Recruitment Process has been conducted at 17 Centres across the State during 8 working days from 14<sup>th</sup> June (Friday) to 22<sup>nd</sup> June 2019 with 90% attendance. Venue-wise details are as follows –

#### **Meritorious Sportspersons – Fair Treatment to All Eligible Candidates Assured**

There has been certain misinformation that is being circulated that while doing the Certificate Verification of Certificates pertaining to Sports Quota Reservation, different standards / procedures were adopted at different Certificate Verification Centres. In this regard, the Board would like to reassure that **all the Candidates who deserve consideration as per the Recruitment Rules under the Meritorious Sportspersons Quota shall be accorded absolutely fair and evenhanded treatment while drawing the Selection Lists of various Posts.**

The Board has gathered data from all the 17 Certification Verification Centres **uniformly** on the eligibility (as per the Recruitment Rules) or otherwise of each and every one of the Candidates who claimed MSP Quota. Candidates who deservedly claimed Meritorious Sportsperson Reservation will be dealt with purely based on their eligibility and **Board has been exercising immense care not to leave out any Sportsperson who deserves to be considered, from the domain of consideration.** In this regard, it is appropriate to adduce here, the relevant extract of our Recruitment Rules for ready reference –

*Meritorious Sports Person (MSP) – Persons who possess the necessary certificate issued by the Competent Authority as on the date of Notification will come under this Special Category and this reservation is applicable to the following categories only.*

*Category (1): A Sportsperson who won medals or represented India in an International Competition / Multi-National Competition in any one of the recognized Games / Sports which are mentioned in Annexure-I of GO Ms No. 74, YATC(Sports) Department, dated 9.8.2012*

*Category (2): A Sportsperson who won medals or represented any State in a National Competition in any one of the recognized Games / Sports which are mentioned in Annexure-I of GO Ms. No. 74, YATC(Sports) Department, dt.9.8.2012*

*Candidates who come under Category (1) and (2) as above shall be considered as per merit secured by them in the Final Selection. When 2 (two) or more Candidates secure same marks, preference shall be given to the Candidate who possesses certificate of Category (1).*

Thus, Certificates **admissible** to claim Meritorious Sportsperson Quota in Police Recruitment are –

- a) **FORM – 1 Certificates (for representing India in an international Competition / Multinational Competition** in one of the recognized Games/Sports) signed personally by the Secretary, National Federation/National Association and
- b) **FORM – 2 Certificates (for representing a State in India in a National Competition** in one of the recognized Games/Sports) signed personally by the Secretary of the State Association

The following Certificates given for representing Universities and School Teams in National / Regional / State level **are clearly not admissible** to claim Meritorious Sportsperson Quota in Police Recruitment –

- c) **FORM – 3 Certificates (for representing a University from the State in the Inter-University Competition at National level / Zonal level / Regional level** in one of the recognized Games/Sports) and
- d) **FORM – 4 Certificates (for representing a State School Team in the National Games for School children** in one of the recognized Games/Sports /Representation at Regional & State level)

Further, only Sportspersons whose achievements are in any of the **Twenty-Nine (29) Games / Sports** mentioned in Clause (19) of Rule 2 of State and Subordinate Service Rules, 1996 r/w GO Ms No. 74, Youth Advancement, Tourism & Culture (Sports) Department, dated 09-08-2012 viz., *Football, Hockey, Volley Ball, Hand Ball, Basket Ball, Tennis, Table Tennis, Shuttle Badminton, Kabaddi, Athletics (16 Track Events and 8 Field Events mentioned in the GO), Swimming, Gymnastics, Weight Lifting, Wrestling, Boxing, Cycling, Rowing, Shooting, Fencing, Roller Skating, Sailing / Yachting, Archery, Cricket, Chess, Kho-Kho, Judo, Taekwondo, Soft Ball and Body Building* **only shall be considered.**
