

SELECT LIST FOR THE POST OF DY. EXECUTIVE ENGINEER (DIST.) ADVERTISED VIDE ADVT. NO. 07/2018

- 1. An advertisement No. 07/2018 advertised for filling in various posts viz. Executive Engineer (Dist.), Addl. Executive Engineer (Dist.) and Dy. Executive Engineer (Dist.) by way of direct recruitment was published on the website of the Company as well as in the leading newspaper in the month of October, 2018. The last date of submission of On-Line application was 06/11/2018 which was extended up to 19/11/2018. Thereafter, a corrigendum to the Advt.No 07/2018 was published due to the change in the Reservation Policy i.e. SEBC and EWS along with the instructions therein. As such, the URL link was available for submission of fresh online application from 01/03/2019 to 21/03/2019. Same was intimated to the candidates on their registered E-mail and SMS and published in the leading newspapers.
- 2. The online tests was held on 14-15th May, 2019 at various test centres. Taking into consideration the information provided in the application form and performance in the online test, the candidates were short-listed for personal interview. The interview of the candidates was carried out on 18-19th July, 2019 at Mumbai.
- 3. Taking into consideration the performance in the online test and Personal Interview, the select list has been prepared. The select list has been drawn by giving 90% weightage to the performance in the online written test and 10% weightage to the personal interview.
- 4. The Select List will not confer any right on the candidate for appointment.
- 5. The selection of the candidates is purely on provisional basis subject to confirmation of the pre-requisites and other conditions as notified in the advertisement.
- 6. The candidate should ensure that he / she fulfils the eligibility criteria regarding educational qualification, experience, age, caste etc., and particulars furnished in the application form are correct in all respect. If any false /incorrect information furnished by the candidate is detected at any stage of recruitment process, then his/her candidature will not be considered.
- 7. Please note that it shall be sole responsibility of the candidate to prove his / her eligibility with respect to the experience in the relative responsible post/position. In case the applicant fails to do so, then his / her candidature will be liable to be cancelled at any stage of recruitment / appointment process.
- 8. The Company will take up verification of eligibility of the candidates with reference to original documents prior to issuance of the appointment letter. The decision of the Company in all matters of recruitment / interpretation shall be final and no individual correspondence will be entertained.
- 9. The candidates who are already employees of the Company, their selection is provisional subject to verification of educational qualification, experience, disciplinary action and F.I.R./vigilance investigation pending etc., if any and other service record.
- 10. The Government of Maharashtra introduced 16% social reservation for Socially and Educationally Backward Class (SEBC) vide GR No. BCC.2018/P.K.581 A/2018/16-B dated 05/12/2018 and corrigendum No. BCC.2018/P.K.581 A/2018/16-B dated 19/12/2018. The provisions of social reservation for SEBC has been adopted by the Company vide C.S. No. 78 dated 21/01/2019 to the Classification and Recruitment Regulation, 2005.
- 11. Advertisement was published as per 16 % social reservation to the SEBC category. However, meanwhile the Government of Maharashtra revised the reservation policy of SEBC vide GR dated 04/07/2019. The GoM vide their letter dated 04/07/2019 instructed to fill up the vacancy of SEBC category of 13 % instead of 16%. Accordingly, the select list of SEBC category candidates has been prepared considering 13 % reservation. Currently the matter is placed before Hon'ble Supreme Court of India and the final outcome as well as subsequent GoM directives in the matter are awaited.

- 12. Selection of all the SEBC category candidates is therefore provisional subject to outcome of the Hon'ble Supreme Court of India and any instructions by the GoM accordingly are received.
- 13. The selection of the candidates is subject to W.P. 9515 of 2019 at High Court Bombay, Judicature Aurangabad.
- 14. While every care has been taken in preparing the results, MSEDCL reserves the right to rectify any inadvertent or typographical error.
- 15. MSEDCL regrets inability to entertain any correspondence from unsuccessful candidates.
